THIS FIFTH AMENDMENT TO AGREEMENT NO. 35224 is made and entered, in duplicate, as of May 9, 2023, for reference purposes only, pursuant to minute orders adopted by the City Council of the City of Long Beach at its meetings on March 5, 2019 and November 17, 2020, by and between LISA WISE CONSULTING, INC., a California corporation ("Consultant"), with a place of business at 983 Osos Street, San Luis Obispo, California 93401, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
35224 (the "Agreement") whereby Consultant agreed to provide on-call environmental,
planning, affordable housing, and community engagement consultant services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to
add \$575,000 for a total not to exceed amount of \$650,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement
to add \$450,000 for a total not to exceed amount of \$1,100,000 and extend the term to
March 5, 2022; and

WHEREAS, the Parties entered into a Third Amendment to add \$100,000 for
 a total not to exceed amount of \$1,200,000 and extend the term to March 5, 2023; and
 WHEREAS, the Parties entered into a Fourth Amendment to add \$255,000
 for a total not to exceed amount of \$1,455,000 and extend the term one (1) additional one year period; and

23 WHEREAS, the Parties desire to add \$280,000 for a total not to exceed 24 amount of \$1,735,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and
conditions herein contained, the Parties agree as follows:
