WHEREAS, City requires specialized services requiring unique skills to be performed in connection with Polygraph Services; and

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35512 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to extend the term to February 3, 2023; and

WHEREAS, the Parties desire to extend the term for one (1) additional oneyear period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2. of the Agreement is hereby amended to read as follows.
