THIS SEVENTH AMENDMENT TO AGREEMENT NO. 34977 is made and entered, in duplicate, as of June 20, 2023 for reference purposes only, pursuant to Resolution No. RES-18-0090 adopted by the City Council of the City of Long Beach at its meeting on June 19, 2018, by and between EMC CORPORATION, a Massachusetts corporation ("Contractor"), whose address is 176 South Street, Hopkinton, Massachusetts 01748, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 34977 (the "Agreement") whereby Contractor agreed to provide data center systems equipment; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to March 30, 2020; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to March 30, 2021 and add the authorized annual amount of \$2,087,000 for a total not to exceed Agreement amount of \$12,779,600; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to July 31, 2021; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to add the authorized annual amount of \$2,087,000 for a total not to exceed amount of \$14,866,600 and extend the term to July 31, 2022; and

WHEREAS, the Parties entered into a Fifth Amendment to extend the Agreement through February 28, 2023; and

WHEREAS, NASPO Contract No. MNWNC-109 entered into a Sixth Amendment to extend the Agreement through July 31, 2023; and

WHEREAS, the Parties desire to extend the Agreement through October 31, 2023; and

WHEREAS, the Parties desire to extend the term through the NASPO

extension;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.D. of the Agreement is hereby amended to read as follows:
- "D. The term of this Agreement shall commence at midnight on June 19, 2018, and shall terminate at 11:59 p.m. on October 31, 2023."
- 2. Except as expressly amended herein, all terms and conditions in Agreement No. 34977 are ratified and confirmed and shall remain in full force and effect.
