THIS FOURTH AMENDMENT TO AGREEMENT NO. 35394 is made and entered, as of May 17, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 20, 2019, by and between ARDURRAGROUP, INC. dba ANDERSONPENNAPARTNERS, a Florida corporation ("Consultant"), with a place of business at 4921 Memorial Highway, Suite 300, Tampa, Florida 33634, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35394 (the "Agreement") whereby Consultant agreed to provide as-needed, on-call consulting services for street design projects in an amount not to exceed One Million Dollars (\$1,000,000) for a period of three (3) years with the option to extend for two (2) additional one-year periods, at the discretion of the City Manager; and

WHEREAS, the Parties entered into a Third Amendment to extend the term to September 30, 2023, attach an updated rate sheet, and update the City Representative; and

WHEREAS, the Parties desire to extend the term of the Agreement by using the final one-year extension option, and attach an updated rate sheet;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- Section 2 of the Agreement is hereby amended to read as follows: 1.
- "2. TERM. The term of this Agreement shall commence at midnight on
