### SECOND AMENDMENT TO AGREEMENT NO. 35872

THIS SECOND AMENDMENT TO AGREEMENT NO. 35872 is made and entered as of July 6, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 21, 2019, by and between KRISTOPHER MCLUCAS LICENSED CLINICAL SOCIAL WORKER INC., a California Corporation (formerly Kristopher McLucas, a sole proprietorship) ("Consultant"), with a place of business at PO Box 4066, Long Beach, California 90804, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with leading bi-monthly Fatherhood Action groups as a supportive space for fathers to learn the skills on how to improve relationships with their children ("Project"); and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35872 (the "Agreement") whereby Consultant agreed to provide these services; and WHEREAS, the Parties entered into a First Amendment to increase the

contract amount and extend the term of the contract for an additional one-year period;

WHEREAS, the Parties desire to increase the contract amount and extend the term of the contract for the term ending May 21, 2024;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows.

"Contractor shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Ninety-Two Thousand Four Hundred Forty-Five Dollars (\$92,445) annually, at the rates or charges shown in Exhibit "B-2"."

- 2. Exhibit "B-1" to Agreement 35872 is hereby amended and replaced with Exhibit "B-2", attached hereto and incorporated herein.
  - 3. Section 2. of the Agreement is hereby amended to read as follows.
- "2. TERM. The term of this Agreement shall commence at midnight on March 1, 2021, and shall terminate at 11:59 p.m. on May 21, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. This Agreement shall not be extended past May 21, 2024 without authorization of the City Council."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35872 are ratified and confirmed and shall remain in full force and effect.
