FOURTH AMENDMENT TO AGREEMENT NO. 35373 35373

3 THIS FOURTH AMENDMENT TO AGREEMENT NO. 35373 is made and 4 entered, in duplicate, as of August 24, 2023 for reference purposes only, pursuant to a 5 minute order adopted by the City Council of the City of Long Beach at its meeting on May 21, 2019, by and between R.S. CAMPBELL CONSULTING, INC., a California corporation ("Consultant"), with a place of business at 330 S. Freeman Street, Oceanside, CA 92054, 8 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be 10 performed in connection with professional services supporting the deployment of the 11 proprietary software system Envision Connect (EC) ("Project"); and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 13 35373 (the "Agreement") whereby Consultant agreed to provide these services; and

14 WHEREAS, the Parties entered into a First Amendment to increase the 15 amount of the contract to One Hundred Forty Thousand Dollars (\$140,000) and extend the 16 term for one (1) additional one-year period; and

17 WHEREAS, the Parties entered into a Second Amendment to extend the 18 term of the contract for one (1) additional one-year period; and

19 WHEREAS, the Parties entered into a Third Amendment to reflect the 20 aggregate contract amount for all terms and to attach an updated rate sheet; and

21 WHEREAS, the Parties currently desire to increase the annual contract 22 amount not to exceed One Hundred Sixty Thousand Dollars (\$160,000), and extend the term of the contract through April 30, 2024; 23

24 NOW, THEREFORE, in consideration of the mutual terms, covenants, and 25 conditions herein contained, the Parties agree as follows:

26 Section 1.A. of the Agreement is hereby amended to read as follows. 1. 27 "A. Consultant shall furnish specialized services more particularly 28 described in Exhibit "A", attached to the Agreement and incorporated by this

reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Hundred Ten Thousand Five Hundred Dollars (\$110,500), annually with a ten percent (10%) contingency in the amount of Eleven Thousand Fifty Dollars (\$11,050) for the term September 1, 2019 through August 31, 2021; not to exceed One Hundred Forty Thousand Dollars (\$140,000) annually for the term September 1, 2021 through August 31, 2023; not to exceed Six Hundred Seventy-Two Thousand Fifty Dollars (\$672,050) for the term September 1, 2023 through April 30, 2024, at the rates or charges shown in Exhibit "B-1."

2. Section 2. of the Agreement is hereby amended to read as follows.

"The term of this Agreement shall commence at midnight on September 1, 2019, and shall terminate at 11:59 p.m. on April 30, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. This Agreement shall not be extended past May 21, 2024 without authorization of the City Council."

3. Except as expressly modified herein, all of the terms and conditions
contained in Agreement No. 35373 are ratified and confirmed and shall remain in full force
and effect.
