2 Cents (\$315,527.26), with an annual increase of six percent (6%); for the term November
3 1, 2023 to October 31, 2024, in an annual amount not to exceed Three Hundred Thirty-
4 Four Thousand Four Hundred Fifty-Eight Dollars and Ninety Cents (\$334,458.90), with an
5 annual increase of six percent (6%) or by the Consumer Price Index (CPI), whichever is
6 greater for the remaining term.”

7 2. Section 2 of the Agreement is hereby amended to read as follows:

8 “2. TERM. The term of this Agreement shall begin at 12:01 a.m. on
9 November 1, 2019, and shall end at midnight on October 31, 2024.”

10 3. Except as expressly modified herein, all of the terms and conditions
11 contained in Agreement No. 35423 are ratified and confirmed and shall remain in full force
12 and effect.






