RES-11-0045 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH MAKING APPLICATION TO AND REQUESTING THE LOCAL AGENCY FORMATION COMMISSION OF LOS ANGELES COUNTY TO TAKE PROCEEDINGS PURSUANT TO THE CORTESE-KNOX-HERTZBERG LOCAL GOVERNMENT REORGANIZATION ACT OF 2000 FOR THE CITY OF LONG BEACH TO ANNEX (AND/OR DETACH) APPROXIMATELY 41.28 ACRES OF PROPERTY

WHEREAS, City of Long Beach ("City") desires to initiate proceedings pursuant to the Cortese-Knox-Hertzberg Local Reorganization Act of 2000, Division 3, commencing with Section 56000 of the Government Code, for the annexation (and/or detachment) of various areas in or adjacent to the City of Long Beach; and

WHEREAS, the City will file an application with the Local Agency Formation
Commission to annex/detach said areas as set forth and more particularly described in
Exhibit "A" (Chart) and Exhibit "B" (Maps), attached hereto and by this reference
incorporated herein; and

21 WHEREAS, the proposal includes changes to the boundary line between 22 the County of Los Angeles and the County of Orange. This proposal is processed 23 pursuant to Article 4, Chapter 2, Division 1 of Title 3 of the Government Code (Section 24 23200 et seq). The proposal also includes a detachment from the City of Seal Beach, 25 detachments from the City of Long Beach, annexations to the City of Long Beach, 26 annexations to the City of Seal Beach and annexation to the City of Los Alamitos. These 27 proposals are processed pursuant to the Cortese-Knox-Hertzberg Local Government 28 Reorganization Act of 2000 (Government Code Section 56000 et seq). All proposals are

linked and no proposal shall be effective until all proposals are effective. The two county 1 2 ordinances shall state that they shall not become effective until every city change of 3 organization is effective. Each city change of organization shall not become effective until 4 all city changes of organization are recorded and the two county ordinances are effective; 5 and

WHEREAS, the Los Angeles County and Orange County Boards of 6 7 Supervisors are proposing to make changes to seven (7) uninhabited areas in the 8 boundary line between the County of Orange and the County of Los Angeles so as to cause the transfer of land as depicted in Exhibit B from Los Angeles County to Orange 9 10 County and from Orange County to Los Angeles County; and

WHEREAS, the City Council of the City of Long Beach reviewed the 11 boundary line adjustment and annexation/detachment proposals at its meeting held on April 5, 2011. The City Council voted to proceed with making application to the Local 13 14 Agency Formation Commission of Los Angeles County to take proceedings for the annexation for those areas described as Areas 1, 2, 3, 4, 5, and 7 depicted on Exhibits A 15 16 and B and voted not to approve any annexation/detachment for Area 6 as depicted in 17 Exhibit A and B; and

WHEREAS, this proposed annexation or reorganization shall be subject to 18 19 the following terms and conditions: the annexation shall be consistent with Government Code Section 56375.3(a) and other applicable laws existing as of the date of the filing of 20 21 this Resolution; and

22 WHEREAS, the reason for the proposal is to provide boundary adjustments 23 of uninhabited areas so that the border between Los Angeles County and Orange County 24 is more closely aligned with the Coyote Creek Flood Channel and will allow for better 25 service delivery and improved public safety; and

26 WHEREAS, a Public Hearing will be held by the Planning Commission to 27 prezone those land areas to be annexed to the City that require a current zoning 28 designation.

The City Council of the City of Long Beach, California, does 3 Section 1. hereby approve the Resolution of Application for Annexation/Detachment, and requests 4 that the Local Agency Formation Commission of Los Angeles County take proceedings 5 for the annexation of territories to the City, as shown in Exhibits "A" and "B" (except Area 6 7 6 as noted more particularly in Exhibits A and B), attached hereto and incorporated herein by this reference, according to the terms and conditions stated above and in the 8 9 manner provided by the Cortese-Knox-Hertzberg Local Government Reorganization Act 10 of 2000.

Section 2. This resolution shall take effect immediately upon its adoption 11 12 by the City Council, and the City Clerk shall certify the vote adopting this resolution.




