RECOMMENDATION:

Recommendation to authorize the City Attorney to pay sum of \$89,000 in full settlement of lawsuit entitled *Long Beach Area Chamber of Commerce et al.*, v. City of Long Beach, Case No. 07-55691

DISCUSSION

The Long Beach Area Chamber of Commerce and its affiliated PACs claimed that the City's voter approved Campaign Finance Ordinance, limiting donations to Independent Expenditure Committees, violated the First Amendment's free speech protections. The issue was fought in the trial court, where the City partially prevailed. On appeal, however, the trial court's decision was reversed. As the "prevailing party" in this civil rights action, the Chamber's PACS are entitled to recover their attorneys' fees. After negotiations, the Chamber's PACS have agreed to accept the compromised amount of \$89,000.00, which we opine is the reasonable settlement value.
