#### ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AMENDING THE LONG BEACH
MUNICIPAL CODE BY AMENDING SUBSECTION
5.87.015.L RELATING TO THE DEFINITION OF "PARK"
AND "PUBLIC PARK" TO INCLUDE ALL CITY OWNED,

**OPERATED OR LEASED PARKS** 

WHEREAS, the City Council of the City of Long Beach adopted regulations relating to Medical Marijuana Collective by adding Chapter 5.87 to the Long Beach Municipal Code by adopting Ordinance No. ORD-10-0007 on March 23, 2010;

WHEREAS, Chapter 5.87 was amended and restated by adopting Ordinance No. ORD-11-0002 on January 18, 2011;

WHEREAS, the City Council of the City of Long Beach now desires to amend Chapter 5.87 to revise the definition of "Park" and "Public Park" to include all City owned, operated, or leased parks;

NOW, THEREFORE, the City Council of the City of Long Beach ordains as follows:

Section 1. Subsection 5.87.015.L of the Long Beach Municipal Code is amended to read as follows:

L. "Park" or "Public Park" shall mean publicly owned, operated or leased natural or open areas set aside for active and passive public use for recreational, cultural or community service activities. For purposes of this Chapter only, all beaches in the City, including but not limited to, all ocean facing beaches, Alamitos Bay, Marine Stadium, Colorado Lagoon, and Marina Park, are excluded from the definition of "Park" or "Public Park."
