ORDINANCE NO. ORD-11-0027

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE USE DISTRICT MAP OF THE CITY OF LONG BEACH AS SAID MAP HAS BEEN ESTABLISHED AND AMENDED BY PREZONING PREVIOUSLY UNDESIGNATED LAND AREAS AS PD-4 AND PD-1, RESPECTIVELY

The City Council of the City of Long Beach ordains as follows:

Environmental documentation having been prepared, certified, 12 Section 1. 13 received and considered as required by law, and the City Council hereby finding that the proposed change will not adversely affect the character, livability or appropriate 14 development of the surrounding area and that the proposed change is consistent with the 15 16 goals, objectives and provisions of the General Plan, the official Use District Map of the City of Long Beach, as established and amended, is further amended by amending 17 18 portions of Parts 6 and 7 of said Map to prezone the subject properties as PD-4 and PD-19 1, respectively. Those portions of Parts 6 and 7 of said map that are amended by this 20 ordinance are depicted on Exhibits "A" and "B" which are attached hereto and by this 21 reference made a part of this ordinance and the official Use District Map.

22 Section 2. All ordinances and parts of ordinances in conflict herewith are 23 hereby repealed.

24 Section 3. The City Clerk shall certify to the passage of this ordinance by 25 the City Council and cause it to be posted in three conspicuous places in the City of Long 26 Beach, and it shall take effect on the thirty-first day after it is approved by the Mayor.




