Subject:

Recommended Changes to the 2012 Federal Legislative Agenda

Each year, City staff reviews the Federal Legislative Agenda and recommends changes to the Federal Legislation Committee and the City Council to ensure that the agenda is up-to-date and addresses the legislative concerns of the City. The 2011 agenda was sent to all departments for their input and includes changes the City Council approved throughout the year. Attached for your review are staff's proposed changes. A summary of these changes is provided in this memorandum to explain why each deletion and addition is recommended.

# **BUSINESS GROWTH & WORKFORCE DEVELOPMENT**

# Item A: Economic Development

Item 8 was added to support small businesses.

# Item B: Workforce Development

Item 2 is added to reflect language that this consistent with current verbiage used to advocate in support of funding for Workforce Investment Act programs and services.

Item 3 is amended to strengthen support for youth workforce development. The concept expressed in the language staff proposes to delete from Item 3 remains intact as noted in Item 2.

Item 4 is amended to reference the Pacific Gateway Workforce Investment Board's unique set of *Demand Sectors* – especially those that support the adopted *Self Sufficiency Standards* and/or serve as a step on an established career pathway.

Item 5 is amended to recognize regional planning and collaborative efforts between local workforce industries and the labor market as essential components to workforce development.

Item 6 is added to highlight the importance of education as a component of workforce development.

Item 7 is added to support the marketability of unemployed or under-employed workers.

Item 11 is added to highlight specific populations in Long Beach who demonstrate a particular need for workforce development interventions. These populations include, but are not limited to: emancipating foster youth, probationary youth, dropouts, military veterans and their spouses, re-entry populations, disabled individuals, older workers and transitioning dislocated workers.

## Item C: The Boeing Company

Item 4 is added to support efforts to obtain ongoing maintenance and 737-MAX aircraft upgrade opportunities in Long Beach.

### HOMELAND SECURITY

### Item B: First Responder Funding

Item 4 was added to oppose federal efforts and/or legislation that would combine multiple homeland security funding initiatives into a single funding mechanism, which could potentially put Long Beach at a competitive disadvantage.

#### **ENVIRONMENTAL**

### Item A: Air Quality

The Harbor Department recommends the deletion of Item 3 as it has been years since this or a similar proposal has been introduced due to the International Maritime Organization's decision to implement Marpol Annex XI, an international approach to reducing marine vessel emissions.

## Item B: Water Quality

Item 1 is amended to include lakes in the City's priorities for clean-up and capital improvements of impaired water bodies within the City.

# Item K: East San Pedro Bay Ecosystem Restoration Project

Staff proposes to amend the title to remain consistent with established missions of the United States Army Corps of Engineers, as well as the official name of the feasibility study.

Staff proposes to delete Item 1 since the United States Army Corps of Engineers has received and expended all funds necessary to conduct and review a federally recognized Reconnaissance Study of the Long Beach Breakwater.

Item 2 is amended to allow the City to advocate for federal dollars to fund the federal portion of the East San Pedro Bay Ecosystem Restoration feasibility study.

## Item N: SERRF

With the California Air Resource Board's adoption of cap-and-trade regulations, staff proposes to amend Item N to emphasize the importance of the City's ability to operate waste-to-energy facilities in a cost-effective manner.

#### NEIGHBORHOOD DEVELOPMENT

#### Item D: HOME Investment Partnerships Program (HOME)

Staff proposes to add Item D in support of the federal HOME Investment Partnerships Program. HOME is the federal government's largest block grant program for affordable housing and the City has experienced a 45% decrease in HOME dollars since 2010.

#### Item A: Good Health

Item G is amended to specifically recognize the homeless veteran population in Long Beach. Existing language in this item allows the City to seek grant funding to assist with addressing homelessness in Long Beach.

## CHILDREN/YOUTH & EDUCATION

Staff proposes to update this section by changing age 18 to 21 as a result of state legislation enacted in 2010 that permits federal foster care dollars to be used for the benefit of youth in the California foster care system, up to age 21.

Portions of this section reference an age range from 0-24 years of age. Staff is not proposing to amend age range, as the language pertains to combating youth/gang violence through workforce development and meeting the health needs of our community's youth population. Youth up to age 24 are eligible for workforce development dollars that meet this purpose.

#### **TRANSPORTATION**

## Item B: Goods Movement

Item 2 is added to reflect the City's support for legislation and/or changes in regulations that would permit local agencies to consider local hiring practices in projects supported with more than 50% non-federal funds.

#### ADDITIONAL ISSUES OF STATE LEGISLATIVE IMPORTANCE

#### Item K: Census 2010

Staff proposes to delete Item K, as the 2010 Census is complete.

#### **NEXT STEPS**

A Federal Legislation Committee meeting has been called for December 13, 2011 to review and discuss the recommended changes. City Council discussion and approval of the Committee's recommendations is expected to take place on December 20, 2011.
