Please be advised that the Long Beach City Council, at its meeting held January 24, 2012 approved the request of Councilwoman Rae Gabelich, Eighth District, to file a protest regarding the subject application based on the fact that licensing the premises would be contrary to City of Long Beach zoning ordinances, since a Conditional Use Permit (CUP) is required.

The City Council also approved the City Manager to withdraw the protest if no appeal is made during the 10-day appeal period for this CUP, which ends at 4:30 p.m. on Monday, January 30, 2012. At such time, if no appeal has been filed, a letter will be transmitted to ABC withdrawing the City's protest of this application by the end of business on Monday, January 30, 2012.

DISCUSSION

TIMING CONSIDERATIONS

The Department of Alcoholic Beverage Control (ABC) granted a one-time 20-day extension to facilitate a Conditional Use Permit (CUP) hearing. The extension granted by ABC requires City Council response by January 26, 2012. The CUP Hearing is scheduled for the Planning Commission meeting of January 19, 2012; however, there is a 10-day appeal period, which would expire on January 29, 2012. As City Council response is due to ABC by January 26, 2012, City Council action is required on January 24, 2012.
