I'd like my option to be considered. I own a house behind the Rite Aide parking lot

My suggestions are not designed to deny Panama Joe's and those bars in Belmont Shore community from a place where people can have fun nor impede their right to conduct business.

It is however the responsibility of their ownership, in coordination with the police, to provide adequate controls that:

- Require Panama Joe's and ALL BARS to pay for additional patrols (by LBPD) during peak operating hours. Approximately 11PM to 3PM. The cost should be shouldered by the bars that opt to stay open after 12pm and server alcohol after that time.
- Close the off several of the busiest streets like Nieto and Granada heading toward the water. Or direct traffic and parking so that residents are not impacted as much.
- Have control points entering into and out of the Shore.

Since I moved my family here 2 years ago;

- I have called the police no less than 4 or 5 times to report fights, disturbances or intoxicated people on or near my property. These incidents were from patrons of Panama Joe's only. We have had other encounters from other bar patrons so it's not an isolated issue.
- Every Thursday though Saturday we constantly see a flow patrons normally leaving the bar drunk, loud or in verbal confrontations.
- Traffic. Just on our street alone during these days and times traffic gets much heavier, disruptive and often people are driving at unsafe speeds and obviously impaired.

Mr. Whitcomb would like to make sure his comments are noted.



# **Dear Planning Commission:**

I'm writing this letter to in regards to an immediate rejection of an alcoholic permit for Quen Ma and the World Market business. As residence of the community <u>I don't</u> approve an issuance of a conditional permit to sell beer or wine at 1030 E. Pacific Coast Highway in the CHW zone. This section and other surrounding sections as well, already have enough businesses that sell alcoholic beverages. If another business is allowed to operate within the radius of this area, then it will add to the existing problem of loitering and illicit activities that already plague our neighborhood. Also, the store's location is around a residential area where children and adolescents are always present and pass on their way to schools, parks, and other destinations. There is also to mention a beautiful Day Care establishment right next store to the World Market. These are some of the reason why I am opposed to the issuing of this permit to Mr.Quen Ma and his business. If Residential peace is not an issue, then children and school safety is. Where Mr. Ma wants to sell beer and wine are in very close quarters to approximately 13 other stores that sell beer and, wine, and all other alcoholic beverages. . The 13 establishments (and those are the establishments that we know about thus far) that sale alcoholic beverages within a minuscule section of the 6th district is appalling! Please look at the map that is enclosed and you may agree that the community is over saturated with liquor stores and mini-markets that sell alcohol. One of the statements that is of genuine sincerity is: "This granting a permit to Mr. Ma, in order to sell more alcohol, will bring more disharmony to a community who has been trying to clean up its act and promote Long Beach, Ca as a safe city whose government cares about the well being of all its people." At the last commission meeting the governing commissioners showed there heart filled integrity and vigilance by recommending that Mr. Ma's permit be denied. # **Dear Council Members:**

I am one of the owners of Panama Joes restaurant located at 5100 E 2d Street. We have operated Panama Joes since 2008 with an Entertainment Permit, and added Patron Dancing in April 2010. This permit is renewed every year after the Police Department reviews a detailed application. When Panama Joes applied for its renewal this year, the LBPD advised us that it was recommending denial of the renewal of our Entertainment Permit.

In preparation for the Council's consideration of our renewal application, Police Chief Jim McDonnell has submitted a June 27, 2012 Memo (the "LBPD Memo") to Erik Sund, Bureau Manager, of the City's Business Relations Bureau. The LBPD Memo states a number of explanations for the Police Department's recommendation to deny the renewal of our permit. This letter summarizes our response to the LBPD Memo.

# **OUR MEETINGS WITH LBPD**

We own and operate seven other restaurants in addition to Panama Joes. We are professionals in every sense. We understand the importance and value to open, direct and two-way communications with the police, and we require that from all of our staff. In all of our establishments including Panama Joes we strive to improve our operations so we are not a problem for the police or the community.

We meet frequently with LBPD and our staff confer daily with LBPD patrols to make sure we keep them aware of what is going on with us, and learn from them what they would like to us pay attention to. Our meetings and phone calls with LBPD routinely involve discussion of arrests and concerns about disturbances. This is part of our open exchange of information.

We were surprised to learn that Vice decided not to support the renewal of our Entertainment License.

# NEIGHBORS SUPPORT RENEWAL OF OUR ENTERTAINMENT PERMIT

The LBPD Memo points out that there are three residents within 100 feet of Panama Joes. Two of them have stated they do not oppose renewing our Entertainment Permit and the third has not contacted the LBPD.

Since we took over Panama Joes in 2008, we have worked closely with the neighbors, both residential and other businesses, to minimize any negative impact from Panama Joes. In coordination with other restaurants and bars on 2d Street, we implemented "Operation SUSH". Our staff has also worked continuously to prevent our patrons from creating any problems in the neighborhood. This is an on-going effort and we remain responsive to new situations and opportunities to be a good neighbor.

# LBPD'S POLICE INCIDENTS ANALYSIS IS FLAWED

The LBPD Memo refers to two crime analyses that cover a two-and-a-half year period. We have never been cited for over intoxication or underage drinking during that time period. Attached to this letter is a Summary Of Details of Police Incidents that we prepared using data from the LBPD and our Manager's Incident Logs which we prepare and maintain daily. Note that while the LBPD Memo to you goes back to December 14, 2009, the incidents it reported to us start in April 2010. We have no information for the incidents between December 2009 and April 2010. However, this Council renewed our Entertainment Permit in April 2011, so presumably any incidents before that were not grounds for denial.

### **DUI'S**

For the 37 incidents reported to us the LBPD from April 2, 2010, 21 of the incidents attributed by the LBPD to Panama Joes occurred away from our premises. 14 of those are DUI's over a two year time period. In response to our May 15 Public Records Request to the City, we asked for any documents pertinent to these DUI's and any protocol or procedures used by LBPD to attribute a DUI to a particular establishment. The City did not provide any documents in response to such requests.

Without some way to test or confirm the accuracy of the LBPD's attributing a DUI to Panama Joes, it seems unfair to use a DUI as a basis for denying our renewal of the Entertainment Permit.

Furthermore, our responsibility as alcohol licensees is to refuse service to anyone who appears intoxicated. Our staff is trained to identify the signs of intoxication, and we cut off customers who show signs of intoxication. It is quite possible, however, that

someone who never appeared to us to be intoxicated, later was found to legally intoxicated at a DUI checkpoint.

We also act responsibly to prevent our customers from driving when intoxicated, and we offer discounted taxi vouchers they may use to catch a cab ride home. We reimburse the cab companies for the discounts our patrons enjoy.

# Drunk In Public Incidents

The majority of the 16 police incidents (over the past two years) that did occur in the vicinity of Panama Joes were for Drunk In Public. LBPD conducts regular Tavern Association Meetings which we attend. In those meetings, the LBPD tells us to cut off serving customers who appear to have had too much to drink and to ask them to leave. The LBPD has said they would not use such cooperation against us.

Our door security also stops people from coming in if they appear to have has too much to drink before they got to Panama Joes.

You will note that nearly all of the Drunk In Public incidents were from customers who we asked to leave or others who were denied entry. To use these incidents as a basis to deny our Entertainment Permit renewal looks like the LBPD has gone back on its word to us and other restaurant and bar operators.

Break In At Neighboring Business

One of the incidents highlighted in the LBPD Memo involved a break-in of a neighboring business by persons who earlier had been drinking at Panama Joes. It is unfair to use this as a basis for denying the renewal of our Entertainment Permit. The LBPD Memo appears to saddle us with responsibility for this criminal conduct that occurred away from our premises and was beyond our reasonable control.

## CONCLUSION

We urge the Council to approve the renewal of the Entertainment Permit with Patron Dancing. We trust the context provided above has given you a fuller picture and demonstrates that Panama Joes is not a law enforcement problem, but is a business that is working with LBPD, the neighbors and the City to improve, often with success.

## MANAGER STATEMENT:M. Perez

I got a call about a code 3 at register 1, booth side, when I asked the man to c me outside, he followed quite respectfully. As we waited outside for the rest of his party to arrive from inside, the gentlemen began to tell me what a piece of shit I was for kicking him out on Christmas, I smiled and apologized. He then stayed quiet and maneuvered closer to me, asking me if I considered myself a "hard man", but before I could answer he head butted me in the nose and followed with a left hook, immediately Tyler and the front door host, josh, responded by grabbing him away from me, but not before he connected another hook to Tyler's face. We were able to calm him down for a moment and move him to the side, over to the barber shop. When we thought he was alright to let go we gave him over to his girlfriend, he then walked over to me and head butted me again, this time with another blow to the stomach, we maneuvered him to the floor until the police got there. I called the police, and waited. The police got there and took him away. Triston, the arresting officer called me later to tell me he had blown a 1.8 and would be spending the night in Jail. I was also asked if I would press charges, I answered no.

I got a code two call (customer confrontation) to the women's room, when I arrived I witnessed staff separating the two parties. I went with veronica and her boyfriend to the kitchen while adam hobbs went to the front with marty and her two daughters(7 &10 years old) I spoke briefly to veronica and her boyfriend in the kitchen to assess the situation. Veronica was being difficult to deal with, however her boyfriend was being very cooperative and helpful in calming her down. I then left staff in the kitchen with veronica and headed to the front to find out what the other end of the story was and get the other party on their way. When I arrived I found marty out front with her girls and her girlfriend. I told marty, who appeared to have had a few drinks, that I was sorry that she had issues with other customers but she would need to leave anyways as it was approaching 10pm and all minors had to leave by then anyways. She said she wanted her purse and her other kid from inside. I went in with her girlfriend to retrieve those items and get them on their way. Her friend apologized to me and said that marty was drunk and sorry for the hassles. When we returned marty 's husband, I think it was her husband anyways, came out with us. At this same time other staff began to take veronica's group out the back door and got them heading down the alley. At this time marty said she was pushed in the bathroom by the veronica and that she hit her head against the wall and that her head hurt. I offered her some ice and asked if she was ok. This all carne out of nowhere as this was the first she mentioned anything about physical contact and any pain she was in. I asked if she needed some ice and if she was ok . she said no she wasn't and that she wanted the police and an ambulance. She told me to call the police as I tried to explain to her that the police would not be able to help her because it was a "he said she said" situation. She was already on the phone with emergency services at this point and told them she needed fire and pd . She became aggressive with me telling me that I needed to detain the other party.
