Subject February 19th Public Hearing comment

I am contacting your office in concerning the issuance of a permit for Entertainment with Dancing by patrons to Gaslamp Partners LLC, dba The Gaslamp Restaurant, 6251 E. Pacific Coast Hwy., Long Beach CA 90803, which is on the agenda for the City Council to be discussed at the February 19, 2013 meeting.

I object to granting this permit on the grounds that this restaurant and its patrons are extremely disruptive to the neighborhood and quiet enjoyment of life in Long Beach, especially on weekends. They frequently are operating past their posted closing time as evidenced by the continuing loud music coming from this establishment, I live across the road from their business and unfortunately suffer through the commotion and disruption they create. I have requested to their ownership directly in the past that they limit access to their parking lot from Loynes Drive

while hosting special events and found that they do so for the next one or two times then return to their past practices.

They are not a responsible neighbor nor one interested in their surrounding community. Granting them such permits as will be discussed on the 19th validates their poor behavior and lessens the quality of life for our city's residents. There should be a balance and to date, there has not been one.
