Environmental documentation having been prepared, certified, 14 Section 1. 15 received and considered as required by law, and the City Council hereby finding that the proposed change will not adversely affect the character, livability or appropriate 16 17 development of the surrounding area and that the proposed change is consistent with the 18 goals, objectives and provisions of the General Plan, the official Use District Map of the 19 City of Long Beach, as established and amended, is further amended by amending 20 portions of Part 29 of said Map to rezone the subject property from R-2-N (Two-family 21 Residential, standard lot) to CNA (Neighborhood Commercial Automobile-Oriented). 22 Those portions of Part 29 of said map that are amended by this ordinance are depicted 23 on Exhibit "A" which is attached hereto and by this reference made a part of this 24 ordinance and the official Use District Map.

25 Section 2. All ordinances and parts of ordinances in conflict herewith are 26 hereby repealed.


