the State Labor Code regarding payment of prevailing wages on Projects awarded 1 2 Proposition 84 Funds.

The City Council certifies that the Project will comply with any 3 Section 3. laws and regulations including, but not limited to, legal requirements for building codes, 4 health and safety codes, disabled access laws, environmental laws and, that prior to 5 commencement of construction, all applicable permits will have been obtained, and 6 7 certifies that the City will work towards the Governor's State Planning Priorities intended to promote equity, strengthen the economy, protect the environment, and promote public 8 health and safety as included in Government Code Section 65041.1. 9

The City Council appoints the City Manager, or designee, as 10 Section 4. agent to conduct all negotiations, execute and submit all documents including, but not 12 limited to applications, agreements, payment requests and so on, which may be 13 necessary for the completion of aforementioned Project.

14 Section 5. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.

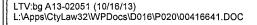
