

ORDINANCE NO. ORD-13-0028

AN ORDINANCE OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH AMENDING THE LONG BEACH  
MUNICIPAL CODE BY AMENDING SECTION 10.54.040  
RELATING TO SKATEBOARDS

The City Council of the City of Long Beach does hereby ordain as follows:

Section 1. Section 10.54.040 of the Long Beach Municipal Code is  
amended to read as follows:

10.54.040 Prohibited – areas enumerated.

A. All streets, alleys and sidewalks in an area bounded by and  
including Vista Street on the north, Nieto Avenue on the east, East  
Broadway on the south and Park Avenue on the west;

B. The pedestrian overpass located on Carson Street, east of  
Faculty Avenue;

C. That portion of the streets and sidewalks of Pine Avenue  
located between Eighth Street and Shoreline Drive;

D. That portion of the street and sidewalks of Shoreline Drive  
located between Ocean Boulevard and Linden Avenue;

E. That portion of the street and sidewalks of Junipero Avenue  
located south of Ocean Boulevard;

F. That portion of the street and sidewalks of Manila Avenue  
located between Pacific Coast Highway and Colorado Street;

G. That portion of the north-south alley between Ultimo Avenue  
and Flint Avenue located south of Fourth Street;

H. That portion of the street and sidewalks of East Second Street

1 located between Quincy Avenue and Bay Shore Avenue;

2 I. That portion of the street and sidewalks of Wilton Street  
3 located east of Termino Avenue;

4 J. The bridge located on Neapolitan Lane West crossing over  
5 the Naples Canal and the Bridges located on The Toledo Street, Ravenna  
6 Drive and Neapolitan Lane East, all crossing over the Rivo Alto Canal;

7 K. That portion of the street and sidewalks of Flint Avenue  
8 located between Fourth Street and Colorado Street, and that portion of  
9 north-south alley between Flint Avenue and Winslow Avenue located  
10 between Fourth Street and Colorado Street;

11 L. That portion of the street and sidewalks of Shaw Street  
12 located between Quincy Avenue and Roycroft Avenue, and that portion of  
13 the north-south alley between Quincy Avenue and Roycroft Avenue located  
14 between East Broadway Avenue and Livingston Drive;

15 M. All streets, alleys and sidewalks in an area bounded by and  
16 including Shaw Street on the north, Ximeno Avenue on the east, the north  
17 sidewalk of Livingston Drive on the south and Belmont Avenue on the west;  
18 except Bennett Avenue between Second Street and Shaw Street;

19 N. All streets, alleys, and sidewalks in an area bounded by and  
20 including East Broadway Street on the north, Quincy Avenue on the east,  
21 the north sidewalk of Livingston Drive on the south, and Ximeno Avenue on  
22 the west;

23 O. That portion of the street and sidewalks of Sixty-Second Place  
24 between Seaside Walk and Ocean Boulevard;

25 P. That portion of the north-south alley between First Street and  
26 Second Street, and east of Termino Avenue;

27 Q. The Belmont Pier Plaza located at the foot of Belmont pier;

28 R. The east-west pedestrian walkway designated as Allin Street

1 between the southerly projection of Thirty-Ninth Place on the west and the  
2 southerly projection of Termino Avenue on the east;

3 S. The Belmont Pier Plaza parking lot located on the beach  
4 southerly of Allin Street between Belmont pier on the west and the southerly  
5 projection of Termino Avenue on the east;

6 T. Midway Street between Thirty-Ninth Place on the west and  
7 Termino Avenue on the east including the entire portion of the roadway and  
8 the entire width of both the north and south sidewalks;

9 U. West sidewalk of Termino Avenue between Ocean Boulevard  
10 on the north and the westerly projection of the south side of Olympic Plaza  
11 on the south;

12 V. That portion of the sidewalks of Pine Avenue and Tenth Street  
13 adjacent to the senior citizen's residential development known as Baptist  
14 Gardens, the address of which is 1011 Pine Avenue;

15 W. All streets and sidewalks within the area south of Ocean  
16 Boulevard between the Long Beach museum of art on the west and the  
17 Taper property on the east, known as Bluff Park;

18 X. The bicycle path located on granted tide and submerged  
19 lands commencing at the Los Angeles River and running in an easterly  
20 direction at or adjacent to the waters of the Pacific Ocean;

21 Y. Roycroft Avenue, between the intersection of Fourth Street  
22 and Colorado Street, including the entire portion of the roadway and the  
23 entire width of both the east and west sidewalk;

24 Z. Third Street, between the intersection of Argonne Avenue and  
25 Granada Avenue, including the entire portion of the roadway and the entire  
26 width of both the north and south sidewalk;

27 AA. South sidewalk of Seventh Street, between Temple Avenue  
28 and Redondo Avenue;

1 BB. The sidewalks adjacent to Belmont plaza pool on the north,  
2 south, east and west sides;

3 CC. The street and sidewalks at the end of Plaza Way, between  
4 Vista del Golfo and Corso di Oro, adjacent to Look-Out Park;

5 DD. Quincy Avenue between Third Street and Broadway, including  
6 the entire portion of the roadway and the entire width of both the east and  
7 west sidewalks;

8 EE. Within the Civic Center Plaza or within Lincoln Park, which  
9 together include all areas bounded by the west right-of-way line of Pacific  
10 Avenue, the north right-of-way line of Ocean Boulevard, the west right-of-  
11 way line of the vacated Chestnut Avenue right-of-way, and the south right-  
12 of-way line of Broadway;

13 FF. Within all areas known as The Promenade South and The  
14 Promenade North, between Shoreline Drive and Third Street, including the  
15 bridges over Seaside Way and Shoreline Drive, and the plaza area  
16 surrounding the children's fountain;

17 GG. Within all portions of the Long Beach Convention and  
18 Entertainment Center site, including sidewalks, other pedestrian assembly  
19 areas, driving aisles, parking lots and parking structures;

20 HH. South side of Fourth Street between Cherry Avenue and  
21 Junipero Avenue and the north side of Fourth Street between Cherry  
22 Avenue and Rose Place;

23 II. That portion of both sides of the street and sidewalks of  
24 Thirty-First Street between Atlantic Avenue and Long Beach Boulevard;

25 JJ. Both sides of Fourth Street between Ximeno Avenue and Park  
26 Avenue.

28 Section 2. The City Clerk shall certify to the passage of this ordinance by

the City Council and cause it to be posted in three (3) conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the Mayor.
