#### Subject: 2014 Proposed Federal Legislative Agenda

Each year the Long Beach City Council adopts a Federal Legislative Agenda, which outlines the City's federal legislative priorities for the coming year. This document provides policy direction to staff on federal issues, and allows the City to support, oppose or work with our federal legislative delegates to advance priorities adopted by the City Council.

At the Federal Legislative Committee meeting on December 4, 2013, the Committee voted to adopt staff's recommended changes for the 2014 Federal Legislative Agenda, with the addition of language to support property tax based financing for energy efficiency upgrades.

As a result of the Committee's actions, the language below and staff's recommendation changes are proposed for the 2014 Federal Legislative Agenda:

#### ENVIRONMENT

Item G: Alternative Energy

"Request the federal government to work with cities to encourage property tax based financing for energy efficiency."

Recommendation: Respectfully request City Council approval of the 2014 Federal Legislative Agenda as recommended by the Federal Legislative Committee.
