10	WHEREAS, pursuant to a "Notice Inviting bids for Job Order Contract No.
11	8, City of Long Beach, California," dated August 18, 2006, and published by City, bids
12	were received, publicly opened and declared on the date specified in said Notice; and
13	WHEREAS, the City Manager accepted the bid of Contractor; and
14	WHEREAS, the City Council authorized the City Manager to enter a
15	contract with Contractor for the work describe in the bid documents; and
16	WHEREAS, the parties desire to extend the term of said Contract;
17	NOW, THEREFORE, in consideration of the mutual terms and conditions in
18	Contract No. 29804 and this Second Amendment, the parties agree as follows:
19	1. Section 4.A. of Contract No. 29804 is hereby amended in its entirety
20	to read as follows:
21	"4. <u>TIME FOR CONTRACT</u> .
22	A. The initial term of this Contract shall begin on November 15, 2006 and
23	shall end on November 14, 2007. The first extended term of this Contract shall begin on
24	November 15, 2007 and shall end on November 14, 2008 or on City's payment of Two
25	Million Dollars (\$2,000,000) hereunder to Contractor for the extended term plus any
26	money remaining from the previous term, whichever occurs first. The second and last
27	extended term of this Contract shall begin on November 15, 2008 and shall end on
28	November 14, 2009 or on City's payment of Two Million Dollars (\$2,000,000) hereunder

to Contractor for the extended term plus any money remaining from the previous terms,
 whichever occurs first."

2. Except as expressly amended in this Second Amendment, all terms
 and conditions in Contract No. 29804 are ratified and confirmed and shall remain in full
 force and effect.
