

SECOND AMENDMENT TO CONTRACT NO. 31524

THIS SECOND AMENDMENT TO CONTRACT NO. 31524 is made and entered, in duplicate, as of January 19, 2011 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on February 9, 2010, by and between MTM & THOMASVILLE CO., a joint venture comprised of MTM Construction, Inc., a California corporation, and Thomasville Construction, Inc., a California corporation, whose address is 16035 Phoenix Drive, City of Industry, California 91745 (collectively referred to as "Contractor"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, pursuant to a "Notice Inviting Bids for Job Order Contract in the City of Long Beach, California," bids were received, publicly opened and declared on the date specified in said Notice; and

WHEREAS, the City Manager accepted the bid of Contractor for Job Order Contract No. 14; and

WHEREAS, the parties entered Contract No. 31524 for the work described in the bid documents; and

WHEREAS, the parties desire to extend the term;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Contract and in this Second Amendment, the parties agree as follows:

1. Section 4.A. of Contract No. 31524 is hereby amended to read as follows:

"4. <u>TIME FOR CONTRACT</u>.

- A. The term of this Contract shall begin on February 10, 2010 and shall end on February 9, 2012 or on City's payment of the not-to exceed dollar amount hereunder to Contractor as specified in Section 2, whichever occurs first."
- Except as expressly amended in this Second Amendment, all terms and conditions in Contract No. 31524 are ratified and confirmed and shall remain in full force and effect.
