

1 SECOND AMENDMENT TO AGREEMENT NO. 32500

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 32500 is made and
4 entered, in duplicate, as of November 11, 2013, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 January 24, 2012 by and between THE RYTE PROFESSIONALS, a California
7 corporation ("RYTE") located at 4141 Ball Road, Suite 517, Cypress, California 90630,
8 and the CITY OF LONG BEACH, a municipal corporation ("Client").

9 WHEREAS, the parties entered Agreement No. 32500 in 2012, wherein
10 "RYTE" agreed to provide professional computer services to Client; and

11 WHEREAS, the parties now desire to increase the amount of said
12 Agreement from an amount not to exceed Six Hundred Thousand Dollars (\$600,000.00),
13 to an amount not to exceed One Million Dollars (\$1,000,000.00);

14 NOW, THEREFORE, in consideration of the mutual terms and conditions
15 herein, the parties agree as follows:

16 1. Section 1.A. of Agreement No. 32500 is hereby amended in its
17 entirety to read as follows:

18 "1. SCOPE OF WORK OR SERVICES.

19 A. Consultant shall furnish specialized services more particularly
20 described in Exhibit "A", attached to this Agreement and incorporated by this
21 reference, in accordance with the standards of the profession, and City shall pay
22 for these services in the manner described below, not to exceed One Million
23 Dollars (\$1,000,000.00), at the rates or charges shown in Exhibit "A".

24 2. Except as expressly amended herein, all of the terms, covenants,
25 and conditions of Agreement No. 32500, as amended and to the extent not contrary to
26 this Second Amendment, shall remain unchanged and in full force and effect.
