THIS AGREEMENT is made and entered, in duplicate, as of January 20, 2012 for reference purposes only, pursuant to Resolution No. RES-12-0011 adopted by the City Council of the City of Long Beach at its meeting on January 17, 2012, by and between MOOSE BOATS, INC., a California corporation ("Contractor"), with a place of business located at 274 Sears Point Road, Petaluma, California 94954, and the CITY OF LONG BEACH ("City"), a municipal corporation.

9 WHEREAS, Section 1802 of the Long Beach City Charter permits the City
10 to make purchases under the purchasing contracts of other governmental agencies when
11 authorized to do so by a resolution; and

WHEREAS, the City desires to purchase one (1) 44-foot Tactical Emergency Response Vessel (TERV) and one (1) 35-foot Critical Incident Response/Patrol Boat ("Patrol Boats"); and

WHEREAS, Moose Boats, Inc. has a Contract under the U.S. General
Services Administration Cooperative Purchasing Program GSA Federal Supply Schedule
84 for the purchase of Patrol Boats, GSA Contract No. GS-07-0507M ("GSA Contract");
and

WHEREAS, Resolution No. RES-12-0011 authorizes the City to purchase
these Patrol Boats by virtue of the GSA Contract;

NOW, THEREFORE, in consideration of the terms and conditions
 contained in this Agreement, the parties agree as follows:

The GSA Contract with Contractor, attached hereto as Exhibit "A", is
 incorporated by this reference as if fully set forth, and the same terms and conditions
 contained in the GSA Contract shall be applicable here except as follows:

A. Wherever the GSA Contract refers to the U.S. General Services Administration Cooperative Purchasing Program GSA Federal Supply Schedule 84, it shall be deemed to refer to the City of Long Beach;

B. Contractor shall sell, furnish and deliver to the City one (1) 44foot Tactical Emergency Response Vessel (TERV) and one 35-foot Critical Incident Response/Patrol Boat of substantially the same type and kind under the U.S. General Services Administration Cooperative Purchasing Program GSA Federal Supply Schedule 84, for an amount not to exceed One Million Five Hundred Forty-Eight Thousand Three Hundred Seventy-One Dollars (\$1,548,371), including tax and fees, for a period extending until the warranty on the Patrol Boats expires. To the extent that the GSA Contract and this Agreement are inconsistent, the following priority shall govern: (1) this Agreement and (2) the GSA Contract.

C. Payment for one (1) 44-foot Tactical Emergency Response Vessel (TERV) and one (1) 35-foot Critical Incident Response/Patrol Boat purchased from Contractor by the City shall be made by the City by the following payment plan:

i. Seven Hundred Twenty-Five Thousand Dollars (\$725,000) - initial payment;

ii. Four Hundred Eleven Thousand Six Hundred Eighty-Five Dollars (\$411,685) - seventy-five percent (75%) complete progress payment;

iii. Four Hundred Eleven Thousand Six Hundred Eighty-Six Dollars (\$411,686) - final payment upon acceptance of the Patrol Boats by City.

D. All warranties shall accrue to the City of Long Beach.

Any notice given under this Agreement shall be in writing and

E. The parties may, by mutual agreement, amend this Agreement with the approval of the City's City Council.

26 Contractor under this Agreement may be assigned by Contractor without the prior written

If there is any legal proceeding between the parties to enforce or interpret this Agreement, or to protect or establish any rights or remedies, the prevailing party shall be entitled to its costs and expenses, including reasonable attorney's fees.
