FIRST AMENDMENT TO AGREEMENT NO. 32018 32018

THIS FIRST AMENDMENT TO AGREEMENT NO. 32018 is made and entered, pursuant to Resolution-10-0149 adopted by the City Council of the City of Long Beach at its meeting held on December 14, 2010, by and between ENTERPRISE FLEET MANAGEMENT, INC., a Missouri corporation ("Contractor"), with a place of business located at 17210 S. Main Street, Gardena, California 90248, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 32018 on or about February 28, 2011, whereby Contractor agreed to lease vehicles to the City of Long Beach; and

WHEREAS, now the City desires to exercise the City's annual contingency option to lease six (6) additional vehicles;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions herein, the parties agree as follows:

- The City hereby exercises the annual contingency option set forth in Paragraph 1(B) of the original Agreement.
- 2. Section 1 of Agreement No. 32018 is hereby amended in its entirety to read as follows:
- "1. "The Santa Ana Specification with Contractor is incorporated by this reference as if fully set forth, and the same terms and conditions contained in the Santa Ana Specification shall be applicable here except as follows:
 - A. Wherever the Santa Ana Specification refers to the City of Santa Ana, it shall be deemed to refer to the City of Long Beach;
 - B. Contractor shall lease and deliver to the City an additional six (6) police vehicles, for a total of nineteen (19), with the understanding these vehicles will be leased from Enterprise FM Trust Lease Agreement, of substantially the same type and kind leased by the City of Santa Ana and on the

same terms and conditions offered to the City of Santa Ana, except as modified by Exhibit "A" attached to and incorporated in this Agreement, for an amount not to exceed Fifty-Seven Thousand Five Hundred Dollars (\$57,500) annually, including tax and fees, for a period of four years, plus a \$27,500 annual contingency if necessary and if funds are available with the option to lease up to six (6) additional units. To the extent that the Santa Ana Specification and this Agreement are inconsistent, the following priority shall govern: (1) this Agreement and (2) the Santa Ana Specification.

C. Payment for the additional six (6) police vehicles leased from Contractor by the City shall be made by the City on delivery to and acceptance of the six (6) police vehicles by the City and submittal of an invoice to the City. Payment is due thirty (30) days after the date of the invoice."
