THIS FIRST AMENDMENT TO SUBCONTRACT NO. 33205 is made and entered, in duplicate, as of February 10, 2014 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on January 17, 2012, by and between CALIFORNIANS FOR JUSTICE, a California nonprofit corporation, with offices located at 115 W. 14<sup>th</sup> Street, Suite C-1, Long Beach, California 90802 (hereafter "Subcontractor"), and the CITY OF LONG BEACH, a California municipal corporation (hereafter "Contractor" or "City").

WHEREAS, Contractor has entered into a Letter of Agreement for the HEAL Zone Initiative: Coalition for a Healthy North Long Beach (hereafter "Prime Contract") with the California Community Foundation (hereafter "Foundation") and Kaiser Foundation Hospitals (hereafter "KFH") (collectively as the "Grantor"); and

WHEREAS, in order to fulfill its obligations to Grantor under the Prime
Contract, Contractor desires to engage Subcontractor to provide for community-specific
strategies in an effort to create a healthy North Long Beach; and

WHEREAS, the parties desire to extend the term;


20 NOW, THEREFORE, in consideration of the terms and conditions 21 contained in the Subcontract and this Amendment, the parties agree as follows:

#### Section 1.0 Subcontractor Objectives:

- 1. Coordinate the Students in Motion club at Jordan High School and hold a minimum of 9 club meetings.
- 2. Train students on policy, advocacy and food justice.
- 3. Conduct meetings with school administrators as needed.
- 4. Conduct a minimum of 1 focus group with Jordan students and a minimum of 1 focus group with Hamilton students around food preferences and issues with school food with the assistance of HEAL Zone's Evaluation Team.
- 5. Identify and facilitate a school-based advocacy project focused on the school food environment.
- 6. Hold an event to make the community aware of the advocacy project.
- 7. Attend and engage in Coalition for a Healthy North Long Beach meetings and events as an active member.
- 8. Submit invoices and reports quarterly by the 10<sup>th</sup> of January, April, July and October 2014.

# Section 2.0 Budget:

Funding will pay for a 20% FTE staff member, meeting materials and travel expenses for HEAL Zone project implementation and subcontractor objectives.
