- 1. Section 5 of Agreement No. 33293 is hereby amended to read as follows:
- "5. <u>TERM OF AGREEMENT</u>. The term of this Agreement shall begin at midnight on October 1, 2013 and shall terminate at 11:59 p.m. on September 30, 2015, unless sooner terminated as provided in this Agreement. This Agreement may be extended for one (1) additional one (1) year period."
