17 WHEREAS, as an owner in the 4th Street Lofts, Lara Solutions is a party to a Parking Easement Agreement which benefits the Successor Agency to the 18 Redevelopment Agency of the City of Long Beach ("Successor Agency"); and 19

WHEREAS, the Parking Easement Agreement requires property owners to 20 21 provide parking for the public and indemnify the Successor Agency against claims made by the public in connection with the use of the parking lot; and 22

WHEREAS, Lara Solutions has applied for a 504 Loan from the U.S. Small 23 24 Business Administration ("SBA") which requires borrowers to obtain waivers of indemnities insofar as the indemnities apply to the SBA or its lenders; and 25

WHEREAS, the requested action will not affect the indemnity obligations of 26 27 the remaining property owners at the 4th Street Lofts;
