A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH CHANGING THE NAME OF OREGON AVENUE BETWEEN ANAHEIM STREET AND 12TH STREET TO WEST COAST CHOPPERS PLACE

The City Council of the City of Long Beach resolves as follows:

Section 1. The name of the Oregon Street between Anaheim Street and 12th Street shall be officially changed to West Coast Choppers Place.

12 The portion of the street or public way involved is shown on the attached 13 diagram, marked Exhibit "A" and by this reference made a part hereof.

Section 2. The City Clerk shall record this resolution with the Los
Angeles County Registrar/Recorder and shall transmit certified copies of this resolution to
the following agencies: Los Angeles County Board of Supervisors, Los Angeles County
Clerk, Los Angeles County Registrar of Voters, Los Angeles County Assessor, and Los
Angeles County Surveyor. In addition, certified copies of the resolution shall be sent to
the Postmaster of the City of Long Beach and to the State Board of Equalization,
Sacramento, California.

Section 3. This resolution shall take effect immediately upon its adoption
by the City Council, and the City Clerk shall certify the vote adopting this resolution.
