

RESOLUTION NO. RES-15-0029

A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AUTHORIZING THE CITY
MANAGER TO PURCHASE COMPUTER SOFTWARE
LICENSES AND RELATED SERVICES THROUGH THE
AGREEMENT BETWEEN THE COUNTY OF LOS
ANGELES AND ORACLE AMERICA, INC.

WHEREAS, the Charter of the City of Long Beach (the "City"), Section
1802, permits the City to purchase services, supplies, materials, equipment and labor
with other government agencies by purchasing under their contracts on a voluntary and
selective basis when authorized by resolution; and

WHEREAS, the City has since 2005, purchased computer software
licenses and related services under a County of Los Angeles Software License
Agreement with Oracle America, Inc. which has expired; and

WHEREAS, the County Of Los Angeles has a new agreement with Oracle
America, identified as County of Los Angeles Software License Agreement Number MA-
IS-1540029-1 ("County of Los Angeles Software License Agreement") for the purchase of
computer software licenses and related services; and

WHEREAS, the City's participation in the County of Los Angeles Software
License Agreement will facilitate acquisition of computer software licenses and related
services as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the
County of Los Angeles Software License Agreement considerably more funds would be
required;

1 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
2 follows:

3 Section 1. The above recitals are true and correct and are incorporated
4 herein by this reference.

5 Section 2. The City Manager of the City of Long Beach is hereby
6 authorized to enter a Master Purchase Agreement with Oracle America, Inc. to purchase
7 computer software licenses and related services of substantially the same type and kind
8 purchased by the County of Los Angeles pursuant to the County of Los Angeles Software
9 License Agreement except as modified by mutual agreement of the City and Oracle
10 America, Inc., and the purchase by the City shall be on the same terms and conditions
11 afforded to the County Of Los Angeles in an amount not to exceed \$500,000 per year.

12 Section 3. This resolution shall take effect immediately upon its adoption
13 by the City Council, and the City Clerk shall certify the vote adopting this resolution.


