CA 90802-4664 through an "Assistance for Hire" arrangement; and 13 14 WHEREAS, the City of Long Beach may be compensated for resources 15 provided or reimbursed for response expenses through such agreements; and Long 16 WHEREAS, Long Beach Fire Department personnel will be compensated 17 for "portal to portal" time, including travel time, working time at the incident, and rest time 18 during the response; 19 NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows: 20 21 Section 1. When the City of Long Beach Fire Department receives compensation and/or reimbursement for incident/event response through an agreement, 22 23 such compensation and/or reimbursement will be used for personnel compensation. 24 equipment use, repair, and replacement, and allowable administrative costs as 25 authorized by the agreement. 26 Section 2. Personnel shall be compensated according to a Memorandum 27 of Understanding (MOU), Personnel Rules and Regulations, and/or other directive that 28 identifies personnel compensation in the workplace.
