- Dr. Matthew Vo and/or Dr. Ed Shackeroff two Long Beach physicians who have expressed a willingness to provide their professional opinions about medical marijuana and the accessibility to this substance in the City of Long Beach. I do not yet have their background information but will provide it once I receive it.

Additionally, to the extent we discuss best practices and identify a city (or cities) in California that appears to have successfully managed the regulation of medical marijuana dispensaries, I would be interested to hear from a law enforcement representative from that particular City to provide information about the city's public safety experiences and related insights.

Edwin Shackeroff, MD FACOG Biographical Sketch April 22, 2015

After growing up in a small family business, and starting his own retail clothing business, Dr. Edwin Shackeroff began his medical career in 1973. He graduated from Baylor College of Medicine and became a board certified Obstetrician and Gynecologist. He founded an OB/GYN practice in Long Beach and Los Alamitos, was Associate Clinical Professor University of California School of Medicine, served as Chairman of the Department of OB/GYN (Los Alamitos). He adopted and taught minimally invasive surgery, consulted and lectured regionally on osteoporosis, liquid based cytology and menopause. He was identified as a Best Doctor in 2002 by Orange Coast Magazine. He retired from medicine in 2003.

Dr. Shackeroff has devoted time and energy to community service in the fields of earthquake preparedness, medical informatics, and robotics, using skills in science, business, strategic planning and "cross pollination".

He has served as Medical Director of the Long Beach Peninsula CERT and was a founding member. He became a guest member of Earthquake Research Associates at Cal Tech, and a Speaker for Earthquake Country Alliance. He has delivered ShakeOut messaging to various communities, including businesses, neighborhood groups, and groups of people with disabilities and special needs, since 2008. He planned, educated, and organized CERT groups at three of his children's schools. He most recently hatched a Teen CERT at Poly High School in conjunction with the Long Beach Fire Department. He recently planned and organized a successful Tsunami awareness program on at the Aquarium of the Pacific featuring a keynote speech by Dr. Lucy Jones and panel discussions with several tsunami experts.

Dr. Shackeroff was a founding member of Bright Eyes Foundation, an affiliate of Children's Hospital Los Angeles Vision Center) whose mission is to prevent childhood blindness. He authored a business plan for its public awareness campaign called "Know The Glow", which explains how an abnormal "red eye" in a flash photograph can detect and prevent blindness.

In 2013 he became a mentor (for strategy, business, and public outreach) for a successful high school FIRST Robotics Competition team. He currently leads an effort establish a community based FRC team and a community based TECH/STEAM Center. This project has involved organizing support from Long Beach Unified School District, California State University, The City of Long Beach, Shared Science (a non profit), Industrial Sponsors (Boeing), FIRST Robotics, Student groups, and experienced mentors. The TECH/STEAM Center is due to open in August, 2015 on a school campus.

Dr. Shackeroff lives on the Long Beach Peninsula with his wife Bibiana Jin Reiser, an Associate Professor of Ophthalmology at Keck/USC School of Medicine and Childrens Hospital Los Angeles. They have two children in local schools.


I have been in personal contact with Mr. Pappas and he has agreed to speak at any meeting this issue is discussed in.

1. Kelly Colopy, Director of Health and Human Services Department.

Kelly Colopy is the Director of the Health and Human Services Department for the City of Long Beach, CA. The Department has over 300 employees in 30 programs working with community partners focused on improving the health of people in Long Beach.
