FOURTH AMENDMENT TO AGREEMENT FOR LEGAL SERVICES

THIS FOURTH AMENDMENT TO AGREEMENT FOR LEGAL SERVICES is made and entered, in duplicate, as of March 10, 2016, pursuant to a minute order adopted by the City Council of the City of Long Beach on February 23, 2016, by and between DAVIS WRIGHT TREMAINE LLP ("Special Counsel"), and the CITY OF LONG BEACH, a municipal corporation ("City"), amending that certain agreement ("Agreement") between Special Counsel and City and identified by the City as Agreement No. 31680.

WHEREAS, an Agreement for Legal Services with Special Counsel was entered into, dated as of March 8, 2010, and such Agreement was amended by a First Amendment to Agreement for Legal Services dated as of January 11, 2012, a Second Amendment to Agreement for Legal Services dated as of January 31, 2014, and a Third Amendment to Agreement for Legal Services dated as of January 31, 2015; and

WHEREAS, a Fourth Amendment to Agreement No. 31680 for Legal Services is required to revise the scope of services and to increase the authorized amount thereunder;

NOW, THEREFORE, IT IS MUTUALLY AGREED by and between the parties hereto as follows:

- 1. Section 1 of Contract No. 31680 is hereby amended in its entirety to read:
- "1. SCOPE OF SERVICES. Special Counsel shall perform all legal services necessary and appropriate to the Matter for which Special Counsel has been engaged, namely: advise, counsel and represent City regarding (i) ongoing proceedings before the California Public Utilities Commission ("CPUC") in connection with the Southern California Gas Company ("SoCalGas") and San Diego Gas and Electric Company ("SDG&E") Triennial Cost Allocation Proceeding; (ii) ongoing proceedings before the CPUC in connection with the SoCalGas and SDG&E North-South Pipeline Application; (iii) ongoing proceedings before the CPUC related to natural gas pipeline safety; (iv) negotiations with SoCalGas regarding pipeline lease agreements;

- (v) cap-and-trade program compliance obligations; (vi) the Southeast Resource Recovery

 Facility; and (vii) ongoing proceedings before the CPUC in connection with the Aliso Canyon
 well failure."
 - 2. Section 3 of Contract No. 31680 is hereby amended in its entirety to read:
- "3. <u>FEE</u>. City shall pay to Special Counsel in due course of payments compensation at the hourly rates identified in the staffing profile and reimbursement of costs as further described herein the "Guidelines" also attached hereto, not to exceed Two Hundred Thousand Dollars (\$200,000) per annum."
 - 3. Section 6 of Contract No. 31680 is hereby amended in its entirety to read:
- "4. <u>TERM</u>. The term of this Agreement shall begin at 12:01 a.m. on February 1, 2016, and shall end at midnight on January 31, 2018 or when the Matter is concluded or on fifteen (15) days' prior notice from the City to Special Counsel."
- 4. The Addendum to Agreement No. 31680 is replaced by the Revised Addendum attached hereto and incorporated by this reference.
