

FIRST AMENDMENT TO AGREEMENT NO. 33917

THIS FIRST AMENDMENT TO AGREEMENT NO. 33917 is made and entered, in duplicate, as of April 25, 2016 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 2, 2015, by and between RA-DA, a sole-proprietor ("Consultant"), with a place of business at 7523 Norton Avenue, West Hollywood, California, 90046, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed architectural services; and

WHEREAS, the parties entered Agreement No. 33917 whereby Consultant agreed to provide these services; and

WHEREAS, the parties desire to extend the term and increase the not to exceed Agreement amount;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 1.A. of Agreement No. 33917 is hereby amended to read as follows:
 - "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Million Four Hundred Thousand Dollars (\$1,400,000), at the rates or charges shown in Exhibit "B"."
- 2. Section 2 of Agreement No. 33917 is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2018, unless sooner

1 terminated as provided in this Agreement, or unless the services or the Project is completed sooner.
