There are 15 core federal and state performance indicators that measure outcomes of the services summarized above. The Workforce Development Bureau exceeded 14 of those measures in this last program year. ## **RESOLUTION NO.**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DESIGNATING THE CITY OF LONG BEACH AS THE ADMINISTERING AGENCY AND SIGNATORY AUTHORITY FOR THE LOCAL WORKFORCE INVESTMENT ACT PROGRAM AND DESIGNATING THE GREATER LONG BEACH WORKFORCE DEVELOPMENT BOARD TO PROVIDE POLICY GUIDANCE AND OVERSIGHT FOR THE PROGRAM

WHEREAS, the City of Long Beach has received notification of a formula
allocation of \$6,160,361.00 from the State of California, Employment Development
Department ("State"), to provide workforce development services for qualifying area
youth and adults (the "Program"); and

WHEREAS, in order to participate in the Program the State requires that a
resolution of the City Council be adopted which designates the administering agency
and signatory authority for the Program.

19NOW, THEREFORE, the City Council of the City of Long Beach resolves20as follows:

Section 1. The City Council of the City of Long Beach shall be the
administering agency and signatory authority for the Program.

Sec. 2. The City Council of the City of Long Beach designates the
Greater Long Beach Workforce Development Board to provide policy guidance and
oversight for the Program.

Sec. 3. The City Council of the City of Long Beach acknowledges that the
City shall be responsible to the State of California, Employment Development
Department, for the expenditure of all funds and liable for those funds not expended in

accordance with the Program, and shall return such funds to the State of California,
 Employment Development Department.
 Sec. 4. The City Council of the City of Long Beach authorizes the City

4 Manager or his designee to execute all documents necessary for the implementation of
5 the Program, including, but not limited to, plans, modifications, adjustments, grant
6 applications, grants, subgrant agreements, and other contracts.

Sec. 5. This Resolution shall take effect immediately upon its adoption by
the City Council, and the City Clerk shall certify to the vote adopting this Resolution.
