

Subject: APPLICATION FOR ENTERTAINMENT WITH DANCING AT SMOOTHS SPORTS GRILL – 144 PINE AVENUE

In response to your request for a recommendation regarding the above named permit application for Entertainment <u>With</u> Dancing, the Police Department recommends **approval**, subject to the following eighteen (18) conditions of operation:

CONDITIONS OF OPERATION

- 1) The operation of the establishment shall be limited to those activities and elements expressly indicated on the permit application and approved by the City Council. Any change in the operation, which exceeds the conditions of the approved permit, will require that a new permit application be submitted to the City Council for their review and approval.
- 2) Entertainment activities shall be restricted to no later than 12 midnight Sunday through Thursday nights, and 2:00 a.m. on Friday and Saturday nights. Outdoor entertainment shall be restricted to no later than 10pm each day of the week.
- 3) Outdoor entertainment shall be restricted to no more than three (3) entertainers, and shall not be amplified in any way. This shall apply to the sidewalk patio and the roof.
- 4) Unless separately applied for, reviewed and approved, no adult entertainment, as defined by section 5.72.115(B) LBMC shall be conducted on the permitted premises.
- 5) Persons under twenty-one (21) years of age shall not be permitted to enter nor to remain on the premises after the restaurant (food services) portion of the establishment has closed.
- 6) Persons under eighteen (18) years of age shall not be permitted to enter nor to remain on the premises after 10 p.m., unless accompanied by a parent or legal guardian.
- 7) Smooths Sports Grille shall not advertise, procure, nor allow any person, performance, show, promotion, or any other event or entertainment that exposes or promotes, encourages, or allows the exposure of the male or female genitals, cleft of the buttocks, the areola or any portion of the female breast below the areola, while at or inside the business.

- 8) Current occupancy loads shall be posted at all times, and the licensee shall have an effective system to keep count of the number of occupants present at any given time. (LBMC section 18.48.320)
- 9) Smoking shall not be allowed inside Smooths Sports Grille at any time. "No smoking" signs shall be posted in conspicuous places inside the club and at the entrance to the business. (LBMC Chapter 8.68)
- 10) The door(s) or windows shall be kept closed at all times during any entertainment activity described in your application, except in cases of emergency and to permit deliveries. Said door(s) are not to consist solely of a screen or ventilated security door.
- 11) No sound shall be audible from the exterior of the premises in any direction except during outdoor entertainment as approved in this permit.
- 12) Smooths Sports Grille, its promoters, or agents, shall not distribute any advertising matter in or upon any public property, or in or on any vehicle in any such place in the City. Distribution of any advertising matter upon private property shall adhere to the following guidelines: By placing the same matter in a receptacle, clip, or other device designed or intended to receive advertising matter.
- 13) The permittee shall provide a minimum of two (2) uniformed security guards during all times that the entertainment activities are being conducted for crowds up to two hundred fifty people. For crowds over two hundred fifty people the permittee shall provide a minimum of one (1) additional uniformed security guard per fifty (50) people. Security guards must be identifiable as "Smooths Sports Grille employees." Should the permittee's operations give rise to a substantial increase in complaints/calls for service, the permittee shall increase security as directed by the Chief of Police.
- 14) The permittee agrees to reimburse the City whenever excessive police services, as determined by the Chief of Police, are required as the result of any incident or nuisance arising out of or in connection with the permittee's operations.
- 15) If any noise, disturbance complaints, or trash left in the parking lot and surrounding area of the business can be attributed to the operation of said business, the Police Department can determine and impose requirements for security officer presence to routinely police and handle these problems.
- 16) All promoters must have or obtain a City of Long Beach Business License prior to conducting entertainment activities governed by this permit. The permittee shall be responsible for all entertainment activities at the location, including those conducted by promoters.

- 17) The permittee must provide all promoters hired to conduct entertainment activities with a copy of the approved permit, which shall include a copy of the approved conditions of operation.
- 18) The permittee shall maintain full compliance with all applicable laws, ABC laws, ordinances and stated conditions.

- Applicant needs to address occupant load calculations and change of occupancy due to proposed dancing. The increase in occupant loads and the change of occupancy will require a formal plan submittal to address life safety issues as required by the California Building and Fire Code.
- Fire sprinkler installation is still unresolved.
- A2.1 Occupancies will require a fire life safety system to be installed.
- Main exit shall be capable of exiting one-half the total occupant load.
- Additional items as required per the California Building and Fire Code.
