

Subject: APPLICATION FOR ENTERTAINMENT WITHOUT DANCING AT THE TROJAN III – 2020 E ANAHEIM STREET

In response to your request for a recommendation regarding the above namedpermit application for Entertainment <u>Without</u> Dancing, the Police Department recommends **approval**, subject to the following eighteen (18) conditions of operation:

CONDITIONS OF OPERATION

- 1) The operation of the establishment shall be limited to those activities and elements expressly indicated on the permit application and approved by the City Council. Any change in the operation, which exceeds the conditions of the approved permit, will require that a new permit application be submitted to the City Council for their review and approval.
- Entertainment activities shall be restricted to no later than 12 midnight Sunday through Thursday nights, and 2:00 a.m. on Friday and Saturday nights.
- 3) Unless separately applied for, reviewed and approved, no adult entertainment, as defined by section 5.72.115(B) LBMC shall be conducted on the permitted premises.
- 4) The permittee shall provide a minimum of one (1) uniformed security guards during all times that the entertainment activities are being conducted, and shall remain in the parking lot for one half hour after closing. Security services shall only be provided by a Private Patrol Operator, properly licensed by the State of California and the City of Long Beach Security. Should the permittee's operations give rise to a substantial increase in complaints/calls for service, the permittee shall increase security as directed by the Chief of Police.
- 5) The permittee shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside any of the entrance/exit doors at all times open for business. This should be done by use of security guards and signage indicating, words to the effect of, "Please respect our neighbors." Signage shall be placed near all doors and exits.

- 6) The permittee shall insure that no vehicles are allowed to park in the parking lot during non-business hours. Any vehicles left in the parking lot after business hours shall be towed.
- 7) The permittee shall install and maintain an effective lighting system that will illuminate the back parking lot and the front of the business. The back parking lot light shall remain on until two hours after closing. The front light shall remain on until one half hour after closing.
- 8) At the conclusion of each event, the Trojan III shall ensure that exiting patrons walk directly to their vehicles, and not loiter in the parking lot or immediate area.
- 9) Current occupancy loads shall be posted at all times, and the licensee shall have an effective system to keep count of the number of occupants present at any given time. (LBMC section 18.48.320)
- 10) Smoking shall not be allowed inside the Trojan III at any time. "No smoking" signs shall be posted in conspicuous places inside the club and at the entrance to the business. (LBMC Chapter 8.68)
- 11) The door(s) or windows shall be kept closed at all times during any entertainment activity described in your application, except in cases of emergency and to permit deliveries. Said door(s) are not to consist solely of a screen or ventilated security door.
- 12) No sound shall be audible from the exterior of the premises in any direction.
- 13) The permittee agrees to reimburse the City whenever excessive police services, as determined by the Chief of Police, are required as the result of any incident or nuisance arising out of or in connection with the permittee's operations.
- 14) If any noise, disturbance complaints, or trash left in the parking lot and surrounding area of the business can be attributed to the operation of said business, the Police Department can determine and impose requirements for security officer presence to routinely police and handle these problems.
- 15) All promoters must have or obtain a City of Long Beach Business License prior to conducting entertainment activities governed by this permit. The permittee shall be responsible for all entertainment activities at the location, including those conducted by promoters.
- 16) The permittee must provide all promoters hired to conduct entertainment activities with a copy of the approved permit, which shall include a copy of the approved conditions of operation.

- 17) Any graffiti painted or marked upon the premises, or on any adjacent area under the control of the licensee, shall be removed or painted over within 24 hours of being applied.
- 18) The permittee shall maintain full compliance with all applicable laws, ABC laws, ordinances and stated conditions.
