

RESOLUTION NO. 1 2 3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH MAKING CERTAIN FINDINGS 4 5 REGARDING THE ACQUISITION OF CERTAIN 6 PROPERTY WITH REDEVELOPMENT FUNDS (PACIFIC 7 ELECTRIC RAILROAD RIGHT-OF-WAY BIKE TRAIL 8 PROJECT) 9 WHEREAS, the City Council of the City of Long Beach adopted and 10 approved a certain Redevelopment Plan (the "Redevelopment Plan") for the Central 11 Long Beach Redevelopment Project (the "Project"); and 12 13 WHEREAS, in furtherance of the Project and the immediate 14 neighborhood in which the Project is located, the Redevelopment Agency of the City of 15 Long Beach, California (the "Agency"), has recognized the need for certain public 16 improvements, which improvements will be located within the boundaries of the Project, 17 and proposes to use redevelopment funds to finance the improvements; and 18 WHEREAS, Section 33445 of the California Community Redevelopment 19 Law (Health and Safety Code Section 33000 et seq.) requires the Agency to make certain findings prior to the acquisition of land and construction of public improvements 20 21 or facilities thereon; and 22 WHEREAS, Section 33678 of the Community Redevelopment Law 23 provides that under certain conditions tax increment funds shall not be subject to the 24 appropriations limitation of Article XIIIB of the California Constitution; 25 NOW, THEREFORE, the City Council of the City of Long Beach resolves 26 as follows: 27 Section 1. The City Council determines that the acquisition of property, 28 more particularly described in Exhibit "A", are of benefit to the Project and the

immediate neighborhood in which the Project is located. This finding is supported by 2 the following facts:

The proposed Pacific Electric Railroad Right-of-Way Bike Trail Project (Project) will further the recommended open space development goals and strategic actions of the Long Beach 2010 Strategic Plan by increasing the inventory of open space and focusing attention on preserving and acquiring open space for those neighborhoods where rapid growth and increased density have significantly reduced potential parks and other open space development opportunities.

The development of the Project will create an additional 6.19 acres of open space in addition to enhancing regional bikeways and creating vital linkages to recreational and community centers throughout the central core of the City. The proposed Project consists of the design and construction of .75 miles of a 15-foot wide Class I bike/pedestrian path, constructed of asphalt concrete, along the Pacific Electric Right-of-Way and .75 miles of Class II bikeway along the street right-of-way. Access points will be located at the intersections of the Project with major arterial streets and bike/pedestrian push buttons, and crosswalks will be installed at all intersections.

20 Sec. 2. The City Council determines that no other reasonable 21 means of financing the above-described improvements are available to the community. 22 This finding is supported by the following facts:

Before the passage of Proposition 13, most of the City's general operating and capital improvements were funded through property taxes. However, the initiative placed severe constraints on the City's ability to use property tax revenues to offset increases in operating and capital costs. It has also been difficult for the City, by itself, to provide sufficient funds to support the construction of major public improvements. In fiscal

The Drake/Chavez Greenbelt Project (Project) would be attractive for school field trips, as a Los Angeles River trail highlight and as an interesting designation for the general public. Direct access from the nearby community as well as the Los Angeles River bicycle trail, will be constructed to the wetlands areas. The on-site trail system would include an on-grade trail up to the marsh edge; with observation platforms equipped with interpretive signage and benches and would be large enough to accommodate small groups. An additional over-marsh trail, a separate on-grade loop trail, observation platforms, individual benches and signage will be developed to accommodate the general public. In particular, residents of the surrounding densely populated neighborhoods are currently underserved in terms of open space and recreational opportunities.

Once developed, there will be increased public access to the Los Angeles River, the river path and access to the wetlands and open space. Educational benefits will be enhanced along the river with outdoor educational programs created and offered by naturalists from the El Dorado Nature Center and marine biologists from the Long Beach Aquarium of the Pacific.

EXHIBIT "A"

DESCRIPTION OF THE PUBLIC IMPROVEMENTS

The acquisition of approximately seven areas of land along the lower Los Angeles River currently owned by Union Pacific Railroad for the proposed development of the Drake/Chavez Greenbelt Project (Project). The Project proposes the creation of a tidal marsh habitat with the development of native shrub habitats; trail linkages and public access from adjacent neighborhoods. This plan would consist of opening a tidal connection to the Los Angeles River and accommodate public access at a relatively high level to provide enhanced opportunities for passive use and elementary education.
