BACKGROUND

I (Officer J Flores #10007) am a Police Officer in the City of Long Beach assigned to the West Division as a Patrol Resource Officer. I am specifically tasked with impacting Community Oriented Public Safety "COPS" locations.

COPS locations are typically long-term problem locations, which may require other city resources in order to eradicate long-term problems.

Miko's bar, which is located at 710 W. Willow Street, has been identified as a possible problem location by the local residents in the area, specifically several who reside on the 2500 block of Main Ave. Under the Long Beach Police Department's COPS philosophy, this location is a COPS location. For further see COPS DR #15-62480.

DISPATCH:

On 11/18/15 at approximately 1826 hours, I (Officer J. Flores #10007) drove to to contact Ricky Oropeza regarding an incident that had occurred on 11/13/15 pertaining to Miko's bar.

STATEMENT

Oropeza stated the following: On 11/13/15 Oropeza's family and his peace were disturbed on different occasions. Oropeza went on to tell me the music being heard from Miko's bar was so loud it felt like the bar was in his living room.

Oropeza went on to provide video footage of three different occasions the back door opened to Miko's bar.

VIDEO SURVEILANCE

TIMESTAMP 11/13/15 0245 HOURS: An unknown male exits Miko's bar through the rear south facing door and walks to his vehicle.

TIMESTAMP 11/13/15 0306 HOURS: An unknown male opens the rear south facing door of Miko's.

TIMESTAMP 11/13/15 0309 HOURS: An unknown female and male exit the rear facing door.

During my investigation I could not hear any music from the video surveillance and asked Oropeza if there was anything wrong with the audio. Oropeza told me there was something wrong with the DVR system, which was why he explained I could not hear any music.

Oropeza desired prosecution for his peace being disturbed and signed a PPA. I provided Oropeza a report receipt
