On 03/27/2016, I (Officer R. Bun #6313) was working uniformed patrol as Unit 1A3. At approximately 0154 hours, I assisted Officer J. Vandyk #10545 (Unit 1A34) who was dispatched to 710 West Willow Street regarding an attempt suicide (Call #0137).

The call stated a female calling party saw a male unknown wearing a white shirt cut his veins and was bleeding. Another calling party called Dispatch and advised Dispatch they saw a male Hispanic cut himself with an unknown weapon and was bleeding.

Officer S. Alatorre #10119 (Unit 1A1), Officer L. Newton #10667 (Unit 1A5), and Officers D. Donnenfield #10550 & Officer J. Wilcoxen #10544 (Unit 1A65) assisted on scene.

While I was in the area canvassing for the subject, Officer Alatorre aired via radio that he had the subject (identified as Jose Rivera) detained at 25th Street and Magnolia Avenue. He requested the Long Beach Fire Department to respond because Rivera was bleeding profusely from his right wrist.

I arrived on scene and observed Officer Alatorre treating Rivera's injury. Officer Alatorre applied pressure on Rivera's right wrist with Rivera's arm elevated as we waited for Long Beach Fire Department.

Long Beach Fire Department Engine 7 and Rescue 13 arrived on scene.

Rivera spoke only in Spanish. Officer Alatorre, a Spanish speaking officer, spoke with Rivera regarding this incident and he was told the following.

Rivera stated he was drinking earlier tonight at Miko's Sport Lounge (710 West Willow Street) with his girlfriend (identified only as Blanca). Rivera had a dispute with his girlfriend and she broke up with him. He was extremely upset over the breakup and cut his right wrist with a beer bottle. He told Officer Alatorre he does not want to live anymore and will continue to hurt himself if left alone.

Officer Donnenfield took photos of Rivera's injury.

Long Beach Fire transported Rivera to College Medical Hospital at Pacific Avenue where Officer Alatorre and I placed Rivera on a 5150 WIC hold

Sergeant E. Matusak #10127 was notified of the released not booked.
