On March 30, 2016 at approximately 2234 hours, my partner (Officer E. Golz #6039) and I (Officer C. Pruiet #10764) while working uniformed patrol as Unit 1C64 assisted 1S13 (Sgt M. Mcguire #5729) at 710 W. Willow Street (Miko's Sport Lounge) with a stabbing incident that just occurred (call# 1711).

Upon arrival, I observed Unit 1C5 (Officer J. Villanueva #5854), Unit DE13 (Officer C. Brammer #10014), and Unit 1C78 (Officer J. Garces #10656 and Officer L. McCourt #6145) on scene. Long Beach Fire Department Engine 7 and Rescue 13 personnel arrived on scene.

Officer Garces attempted to find a crime scene in front of 755 W. Willow Street but was unsuccessful. Officer Garces spoke to a witness who observed the victim (later identified as Edward Reyes) arguing with the suspect. Officer Garces also spoke to a witness inside of the bar as well. For further see his follow up report.

While outside the entrance doors to the bar, I observed small, red droplets believed to be blood in small groups. The droplets led into the bar and stopped where Reyes was lying on the ground face up, just south of the entrance doors. Reyes was holding the left side of his body, underneath his left armpit. I observed a circular red stain on his shirt under his left armpit, which I believed to be blood. Long Beach Fire Department personnel removed Reyes's shirt as they rendered aid to him and I observed a small, half-inch puncture wound on his left trapezoid, under his left armpit with dried blood around it. Long Beach Fire Department Rescue 13 transported Reyes to Memorial Hospital and Unit 1A3 (Officer K. Chang #5508) accompanied him.

According to witnesses, the stabbing incident did not occur in the bar but at an unknown location.

I then spoke to a witness, an employee working as a bartender (later identified as Christine Chesser) and she told me the following:

Chesser started her shift at approximately 1915 hours and observed Reyes in the bar. Chesser said Reyes did not appear to be under the influence of alcohol and was not in any confrontation with anyone at the time. Chesser observed Reyes leave the bar but does not know where he went. Approximately an hour later, Chesser was cleaning the bar when she noticed Reyes enter back into the bar entrance door. Reyes was holding his left side, which was bloody and had a hammer in one of his hands. Chesser then said a few patrons of the bar helped Reyes to the ground and tried to render aid to him by placing towels underneath his bleeding arm. Chesser then

noticed the suspect enter into the bar through the entrance door and remove his beanie. The suspect then yelled, "What the Fuck!" several times while waving his right arm around. The suspect then looked around at the bar and then backed out the entrance doors.

Chesser described the suspect as the following:

Water Control of the State

Male Black, light skinned, 5'7", 125 pounds, with short twisty braid brown hair, wearing a gray zip up hoodie and gray beanie type hat. Chesser could possibly identify the suspect if seen again.

Officer Brammer detained a subject matching the description of the suspect. Chesser could possibly identify the suspect if seen again and participated in a field show up. I read her the field show up admonishment per P.D. form 4100.35A. The field show up was negative and the subject was released without incident.

Officer Villanueva photographed the red droplets in and outside of the bar. Officer Villanueva also collected Reyes's clothes and hammer. For further see her photos and evidence.

Unit 1A33 (Officer W. Lavarro #10021) arrived on scene and towed the victim's vehicle (White Volkswagen Jetta Lice Lice). A dog was found in Reyes's vehicle and Animal control was called to the scene and took custody of it.

The bar has security cameras on the outside of the building, which were recording during the incident. A copy of the footage was not available at the time but day shift Sergeants were notified by Sgt. M. Mcguire that the footage would be available for pick up at a later date.

as Unit 1C78. We assisted Unit 1C5 on an assault with a deadly weapon at 710 W. Willow St. (call #1711).

Upon arrival several units were already on scene along with fire personnel.

I spoke to WIT Gerry Lee Camargo who was sweeping the parking lot of Five and Two Teriyaki (755 W. Willow St.) and he told me the following:

On 03/30/16 at approximately 2220 hours, Camargo was on the corner of Oregon Ave. and Willow St. He observed a subject (later identified as VIC Edward Reyes) walking eastbound along the north sidewalk in front of Discount Club Store (located at 805 W. Willow St.) VIC Reyes was holding a hammer in his hand and he was arguing with the SUS. The SUS was walking eastbound in the westbound lanes of Willow St. from Golden Ave. in front of the VIC. VIC Reyes asked WIT Camargo, "What's up?" as he walked passed WIT Camargo. VIC Reyes then walked southeast diagonally across Oregon Ave and Willow St.

WIT Camargo described the SUS as a male Black who was wearing a dark gray or black hooded sweater. WIT Camargo could not identify if he saw him again. No further details provided.

I then spoke to WIT Pat Ann Scott who was inside Mikos Sports Lounge and she told me the following:

On 03/30/16 at approximately 2220 hours, she was inside Mikos Sports Lounge when a subject (later identified as VIC Edward Reyes) came into the bar an he was holding a hammer. VIC Reyes yelled out, "I'm bleeding! Somebody sliced me!" VIC Reyes then put the hammer down on a table near the front entry door and layed down on the floor. WIT Scott observed the SUS attempting to come into the bar. The SUS appeared very agitated and was holding a silver knife with a point on the end. Several patrons stopped the SUS from entering the front door by blocking the door with their bodies. The SUS then fled the scene in an unknown direction.

WIT Scott described the SUS as light skinned male Black with "twigs" or short braids in his hair. WIT Scott may be able to identify the SUS seen again.

Unit De13 had a subject detained on the corner of Daisy Ave. and Willow St. WIT Scott was transported to complete a field show-up. The field show-up was negative. For further see Field Show-Up Form. Prior to transporting WIT Scott, I read the Field Show-Up Admonition.

Narrative

I, Officer J. Villanueva #5854, was dispatched to 710 West Willow Avenue, regarding a stabbing that had just occurred, Call #1711.

Upon arrival, Victim Edward Reyes was lying on the floor with a stab wound to his right side, just under his armpit.

I took over holding pressure on the victim's wound from Officer Brammer and as I was doing this, I asked the victim if he knew who had stabbed him. Victim Reyes stated he did not know who he was, but he was a guy who had been following him around for "a while".

At this time, Long Beach Fire Department personnel arrived on scene and began giving the victim medical treatment.

I took photos of the victim and the scene.

Witnesses inside the bar stated when the victim came into the bar he was holding a hammer. I found the hammer sitting on a table near where the victim had laid down. I took photos of the hammer, recovered the hammer and maintained possession of it until placing into Evidence.

Narrative

I (Officer Chang, K #5508) was dispatched to assist officers Golz #6038 and Pruiet #10764 with a stabbing that just occurred. I was dispatched to Memorial Hospital to contact the victim, Edward Reyes. Upon arrival I saw that the victim was in a trauma room and I could not contact him. The victim was being treated for a collapsed left lung by Dr Ghobrial.

I was able to speak with the victim prior to his chest tube. The victim had a stab wound to the left side of his chest. The victim had a breathing mask on him and was being prepared for a chest tube. The victim had a hard time breathing and speaking. He wenched from pain constantly.

The victim stated that he was driving a white VW Jetta around 710 W Willow. The victim knows there is a group of people following him and he noticed one of them following him. He made a U-turn to see if the subject was following him and exited his vehicle with a hammer to protect himself. The victim described the suspect as Male, Black, 20-30 years old, wearing unknown clothing. The victim stated that he was unable to defend himself and was stabbed. Emergency staff placed a chest tube in the victim.

I was assisted by Officer Paul, R #10168 who photographed the victim after he was treated. There was bandages on the victim's injuries. I tried to interview the victim but all he would so was complain about his inability to breath and he asked that I stop talking to him. The victim did state that the suspects were hired to follow him. The suspect could not say how long he has been followed and did not want to sound, "Crazy anymore".

Narrative

On 03-31-16 at 1528 hours, my partner (Officer J. Salazar #6179) and I (Officer T. Forster #10770) responded to Miko's Sports Lounge located at 710 West Willow Street to view video surveillance footage of a stabbing that occurred last night (03-30-16). For further on the incident see main report.

I contacted the owner of the bar, Damitresse Yancey, who was able to access the video surveillance footage of the incident, and replay it for us. I viewed the footage, beginning from 2220 hours, according to the time stamp on the video. I observed the following:

The victim (a male subject in jeans and a white t-shirt) first appears on the video in the parking lot rear (south) of the business. The subject walks back and forth in the parking lot, then gets into the driver's seat of a white sedan, and pulls out of the parking lot, turns northbound on Maine Avenue, then westbound on Willow Street.

The victim reappears on the video several minutes later (approximately 2237 hours according to the time stamp on the video). The subject walks into the view of the camera in front of Miko's Lounge. The victim has what looks like a white paper bag in one hand, that he is possibly eating something out of. The victim stands near the front of Miko's for a few minutes, then walks out of view of the camera.

At approximately 2241 hours, according to the time stamp on the video, the subject walks back into view of the camera. He is no longer holding the white bag, but appears to have an object in his right hand. He approaches two men standing in front of the bar, stands by them for a few seconds, then turns and takes a few steps westbound on the sidewalk in front of the bar.

Narrative

Then the suspect (a male subject in a dark colored hooded sweatshirt, with the hood up) walks into view of the camera. The suspect appears to have been walking eastbound on the sidewalk towards Miko's. The victim and the suspect confront each other and have a short scuffle, during which it appears the suspect stabs the victim near his left armpit. The suspect turns and walks westbound out of view of the camera. The victim turns and walks back to Miko's, and goes inside.

The victim can be seen inside Miko's holding his left armpit area. Several patrons are also in the bar. Someone inside the bar gives the victim a towel, which he holds to his armpit. The victim stays inside Miko's, near the front of the bar.

After a minute or so, the suspect reappears on the video outside of Miko's. The suspect approaches Miko's and goes inside. After the suspect enters the bar, he pulls off the hood of his sweatshirt, revealing a beanie he is wearing underneath. The suspect tries to approach the victim inside the bar, but some of the bar patrons hold the suspect back. The suspect leaves the bar, and walks westbound on Willow Street until he is out of view of the camera.

The victim stays inside the bar until police arrive at approximately 2247 hours, according to the time stamp on the video.
