I (Officer J Flores #10007) am a Police Officer in the City of Long Beach assigned to the West Division as a Patrol Resource Officer. I am specifically tasked with impacting Community Oriented Public Safety "COPS" locations.

COPS locations are typically long-term problem locations, which may require other city resources in order to eradicate long-term problems.

#### LOCATION - 710 W. Willow Avenue (Miko's bar)

710 W. Willow Avenue has had several different names and owners; however it has always been a bar. The bar is currently named "Miko's bar". The current owner of the bar and the ABC license holder is (DedeYancy/Enald'sWay).

Miko's bar has been identified as a possible problem location by the local residents in the area, specifically several who reside on the 2500 block of Main Ave. Under the Long Beach Police Department's COPS philosophy, this location is a COPS location.

#### **PROBLEM**

Some of the allegations being alleged by the residents are loitering behind the bar, public intoxication, loud music being emitted from the bar and vehicles, defecating, urinating, drinking in public and marijuana use. There has been an uptick of calls for service to the bar and the parking lot. The direct parking lot for the bar goers is just south of the bar, directly behind it, as well as off street parking.

#### **HISTORY**

This location was first brought to our attention on 02/21/2014 and was referred to both business licensing and nuisance abatement.

This location resurfaced again on 05/22/2015, when Celina Luna, Chief of Staff to Council Member Robert Uranga, notified Lt. Michael Lewis of the issues that were brought to their attention.

Using department resources, I ran Calls For Service "CFS" for Miko's and they were as follows: From 01/01/2014-12/31/2014 CFS 133 year to date and CFS for 2015 are 73.

### **NEIGHBOR ISSUES**

The problems at Miko's bar are heightened by the fact there is a residence right across the alley where the parking lot is located. The south facing rear emergency exit door is allegedly being used as an access point. Every time the door is opened the bar noise/music can be heard by the residents in the neighborhood, causing them to call the police, and creating a CFS. The residents on Maine Avenue have called the police numerous times regarding the loud, vulgar behavior by bar goers. The residents are concerned that the bar owner does not care about the peace and quiet of the neighborhood. They also believe that whenever the police are called, the security guard usher's everyone inside. For this same reason, they believe the bar employees may be listening to a scanner, therefore putting them on notice when the police are on their way to the bar.

The residents feel that the City is not doing anything to assist them with their problems, especially since they've been complaining for over a year and a half and nothing is being done.

### SARA MODEL

The SARA model is a commonly used problem solving method in the COPS philosophy. It was used on this location to identify and resolve the issues. SARA stands for Scanning, Analyze, Response, and Assess.

### Narrative

#### SCAN:

On June 15, 2015 a meeting was held at the Long Beach Police Department, West Division with the residents of the 2500 block of Maine Avenue. Commander Smith, Lt. Lewis and Jose Vazquez attended the meeting. The purpose of the meeting was to listen to the resident's concerns regarding Miko's.

#### ANALYSE:

After the meeting, Police Department staff met internally to decide on a course of action to take in order to determine whether the allegations being made were actually taking place or being exaggerated. Sgt. Kenneth Green who was present at the meeting and was tasked with placing a premise history on the location for a silent dispatch, just in case the bar personnel did have a police scanner and were monitoring the calls.

On September 24, 2015 we had a second meeting with the residents in order to communicate with the residents how they can help us, help them.

### EMAILS BEING DOCUMENTED PER COMMANDER SMITH

The following Emails are a collection we have received via department email, from Tonnete Kadrmas:

03/26/2015

City representatives,

We live on the 2500 block of Maine Ave. in Long Beach. We are very concerned about the on going nuisance behaviors and activities coming from Miko's Sports Lounge and its patrons.

We are sending several audio emails to you that document the most recent disturbances generated from the bar and its patrons. The Long Beach City Council voted to deny Mikos Sports Lounges application for a permanent Entertainment Permit, with dancing, 7 days a week, at the council hearing on March 17th, 2015.

At the hearing several council members encouraged the owner of the bar to build a better relationship with her neighbors. Unfortunately there has been an upturn in the disturbance activity since the hearing.

We believe the audio recordings are part of the documentation that the peaceful enjoyment of our long established family neighborhood continues to be impacted due to Miko's Sports Lounge.

Mr. Mallery,

We are the Maine ave. Neighborhood group. We are sending you an announcement regarding a scheduled live entertainment event at Miko's Sports Lounge tonight. The posting states that Patrick Fowler, who is a comedian, will be performing LOL Fridays at 9:00pm.

Per your phone contact with Tonette this morning, you have said that there is no permit for this event and that you would forward the announcement to the police department. You noted that we could call PD tonight and they could enter the bar to observe if the live entertainment takes place.

You also informed Tonette that the PD recommended approval for live entertainment at Miko's on May 29th and 30th for a DJ and that the permit has been issued by your department. We are disappointed that once again based on the past year and a half of disturbances coming from Miko's, they are being rewarded for bad behavior.

We appreciate the time and attention your office and other city departments have spent related to the on going problems that the city and our neighborhood have experienced due to Miko's Sports Lounge. Thank you,

I'm writing this email to share my PERSONAL feelings and views of this weekend living next to this NIGHTCLUB Miko's Bar with another 3 DAYS TEMPORARY ENTERTAINMENT PERMIT.

DeDe's Bar owner and business partners actions, decisions and greed, ARE COMPROMISING THE SAFETY OF MY FAMILY'S LIFE, MYSELF AND OUR PROPERTY.

I URGE YOU, IMPLORE YOU NOT TO ISSUE ANYMORE ENTERTAINMENT PERMITS TILL YOU FULLY INVESTIGATE AND UNDERSTAND WHAT YOU'RE PUTTING US THROUGH.

A tragedy can still be avoided. Saturday night was a terrifying experience. I'm still shaken with different emotions: SCARED, UPSET, DISBELIEF, HOPELESS BUT MOST OF ALL LET DOWN.

I hope that you get to read this entire email so you can understand how I feel please excuse my misspelling.

#### THURSDAY OCTOBER 1st

Was a very "normal" night, low bar patrons traffic some of them arrived and leave blasting their car radio sound system, loud foul language, drinking out of their cars parked behind the bar

parking lot and on Maine st. Loitering in the alley and around my house, loud laughter, our house front sidewalk is the people's spot to talk on their phone or to walk back and forth due to their consumption of alcohol and/or drugs the most frustrating part is that the bar management/staff not only they allow this behavior but lots of time are part of it with their private events.

### FRIDAY OCTOBER 2nd

Mr. Daniel Phillips from the health department was here in my house from 9:30pm till 2:00am to collect the bar noise decimal levels UNFORTUNATELY for me and my family Friday was not the NIGHTCLUB NIGHT he got to

absorb only the "normal" bar night incidents witch includes someone URINATING in my front yard and ME asking them to urinate somewhere else while the rest of the loitering patrons threaten me to kick my ass and AGAIN like a little wimp I went back inside my house upset embarrass not feeling very proud of myself for my inability to protect my house without jeopardizing my family's safety. Again I'm very sad that the bar did not have a DJ or entertainment this night so Mr Phillips could had witness our loud bass music misery coming out of the bar that keeps MY FAMILY away every other weekend from our house. WE HAVE A LOT OF SLEEPOVERS WITH DIFFERENT FAMILY MEMBERS IN THEIR LIVING ROOM not only so my WIFE AND KIDS can get some sleep but to KEEP THEM SAFE.

#### SATURDAY OCTOBER 3rd

Hell broke lose this Saturday (bass noise coming out of the bar was bad) First of all we stayed behind in our house for the weekend because Mr Phillips was coming this weekend. we decide to have my sister-in-law's first baby shower Saturday from 6:00pm to 10:00pm in our house backyard. (Mostly family and few friends. 90% women)

Between lots of food and lots of games lots of gifts to open everyone having a good time the celebration went on longer than expected. Our house doors are closed front and back the bar patrons started to arrive, noise and commotion outside was normal for us, most of our family knows what we're going through with this bar but we apologize to those who didn't know about our situation and assure them that other than noise they don't have to worry about nothing. ("BOY WAS I WRONG".)

My wife came inside the house late at night all scared telling me that someone pounded in our concrete backyard wall cursing as you can imaging all the girls are frightening at this point. A car had their sound system blasted I couldn't understand what the argument was about I went cautiously outside through my house backdoor to take a peak. I noticed one the bar security guard (I know him as Vinnys nephew) talking and finger pointing towards my house to a bunch of agitated crowd. Well out of nowhere the F word was drop on me on many different ways like theirs no tomorrow. Including "I'm going to blast this fucking bitch right now" by this bar patron while others trying to calm him and two other very agitated guys down I get on my phone and I called PD right away I didn't see a gun or anything on them but I give the description of the car and license plate to the dispatch just in case. The security guard walked towards me while I'm still on the phone with PD I warn him to get that F back but keeps coming and stops right where the alleyway ends and my property starts. Then he says I'm trying to help you out dumbass. At that time I didn't know what was going on meanwhile I still have the pd dispatch on the phone I'm trying to give them more description and information while I'm cursing the security guard to get that F out of my face at that point he started take fighting posed and told to make him back off the dispatch told me to go back inside and lock my door that officers were in their way. Call #1652.around 11:30pm the crowd agitators left right before your responding officers arrived. Two officers came to my house I told them what happen then walked over to talked to the security guard then they came back to tell me that he was told not to approach or talked to me anymore. As soon as the police left two ladies asked me if they can talked to me they were walking in my front sidewalk.

They heard everything and felt bad for me they said.

"They (meaning the security staff) were telling the patrons to lower their car radio because this asshole (meaning me) was going to call the police. "we have no problem ourselves if you want to hangout for while but just watch out for this guy. The ladies went on saying that that's wrong for throwing me under the bus. that this guys were already upset because they didn't let them inside the bar and started pounding in my wall out of frustration saying "come out motherfucker" f snitch and other things like that. So when I went outside to investigate the wall pounding I had already a big target in my forehead. I don't know if the guard (vinnys nephew) was the one throwing me under the bus or he really was trying to protect me.one thing is for sure I have no idea why they have to use me as an excuse when they can't control their crowd. Two of your units were on willow with the speakers "dispersing" the crowd in front of the bar. I THINK THEY USE A THIRD PARTY PROMOTER AGAIN to advertise this Saturday's event witch in two other occasions has resulted in massive uncontrollable crowds that get refuse or rejected by the bar and they stayed around the bar front in rear and around our the street to drink out of their car and looked for trouble in our street.

A FORMER CLEANING GUY WAS PROMOTED TO A SECURITY GUARD RECENTLY (good for him) but the lack of proper training put us and them also in danger when things escalate like Saturday night. I DON'T THINK THE PAPERWORK FOR SECURITY COMPANY GIVEN TO THE CITY IS THE ONE PROVIDING THE

As far as I know there was not an OEP. I don't know if they had any entertainment. Perhaps the officers who followed up the call checked inside to see what was going on?

Anyway, my car was parked in the street and the next morning I woke up to this(see pic below) in front of my car. HUMAN FECES! Disgusting! Now I can't prove this was a Miko's patron, but I do think it is coincidental that we find this kind of thing only after an event at Miko's, during which my husband called PD about a person blocking our driveway....

Can you confirm whether (1.) Mikos Sports Lounge, 710 W. Willow st., has been approved for an OEP for the weekend of October 31st, 2015?

Attached are 2 social media flyers that announce a "Monster Ball" event at that location on Halloween, October 31st. Thus far there are nearly 2000 guests invited on the 2 sites alone. As you know, the bar is located in a residential area.

Activities include entertainment and dancing according to the announcements on <u>Heyevent.com</u> <a href="http://Heyevent.com">http://Heyevent.com</a> and Chuckie Millers face book page, ("host Chuckie Miller Entertainment"). The event postings also state that the party starts at 9:00pm and ends at 2:00am.

It is our understanding from speaking with you and other Long Beach city representatives that when the bar has an OEP it must start at 6:00pm and end at 10:00pm. Further, the permitted event must state whether dancing is part of the activities and entertainment must be clearly described.

We are also asking that all city representatives included in this email, that are part of the OEP process, (4). review the OEP application (if currently on file) and check it for accuracy, (i.e. adequate security coverage, is security company registered with Long Beach, do OEP's require that the promoter and event entertainers file appropriate paperwork with the city; if so, have they, etc).

Lastly, (5). we strongly urge you and all city representatives included in this email who are involved in the OEP process; to rescind the OEP. The bars' events, permitted or not, have had a negative impact on our residential community. Please stop rewarding Mikos bad behavior.

On 11/13/15, Ricky Oropeza sent an email to Commander Smith and I regarding a disturbance he had recieved:

Commander Smith and officer Flores.

Mikos bar continuous disturbing our home peace, I'm very frustrated. My daughter Thayz was very upset this morning she couldn't get enough sleep AGAIN because she was awaken by bar patrons coming out of the way beyond the permitted business hours.

We have video of bar patrons leaving the bar intoxicated through the back door till 3:20am of this morning and as you know they don't go home quietly including DeDe the bar owner.

I'm respectfully asking for a report complaint against the bar directly.

Just to give you a picture of how my daughter's day went on yesterday Thursday 11/12/15

Thayz (16) attended her normal classes hours at Millikan High School @ 1:40pm she had training with the school soccer team till 3:00 then she had training @ 4:00 with Fram club soccer till 6:00

Came home took a shower had dinner then do homework till around 10:00pm shortly after she went to sleep only to be awakened around 2:30am by loud bar patrons my wife said that they went back to sleep around 4:00am she woke up at 6:00am to take a shower and get ready to go to school this morning.

My daughter is straight A student that includes 3 AP classes she works very hard everyday. IS THIS FAIR? Please let me know how to proceed

(This email is intended for your eyes only)

I hope you had a nice vacation. I'm very sorry I have to bother you in your first day back but I'm very desperate. I been staying away from my house every weekend as you know not only because our peace and our sleep is disturb by mikos bar but to protect my family from fault language and inappropriate bar patron behavior as well of me losing my head trying to protect them.

I'm very frustrated, I know to stayed away from the bar on weekends nights at least I thought I knew. But IM SO WRONG, we just came back home Sunday at 4:30pm

Our neighbor save a package left in our porch on Friday for something my daughter Thayz purchase online. Shortly after we got home my daughter was going to go 3 doors down to go get the package but as she open our front door unfortunately she got to see a bar patron urinating right across the alley on the side of my house. She came right back inside and told me. I went outside and the patron was getting something out of his car then went inside the bar from the back door. I took a cellphone picture of his license plate. I have everything on our camera system.I did not called the police. THIS IS NOT THE FIRST TIME IT HAPPENS (the last time I reported this to the nuisances city department nothing was done)

I don't called your department much anymore because even when they get patrons in what it looks to me a clear violation ether from disturbing the peace, or playing loud music at 1:00am out there car.THEY DO NOTHING. This past weekend there was a shooting that began with an argument inside the bar and ended with a woman being shot in the head outside in the alley. She remains in the hospital in critical condition. There were at least 4 shots, beginning at 12:33 am followed by screaming and much chaos. There were 3 men yelling in front of my house at about 1:05 am, then they quickly got into cars parked in front of my house and sped off. My family visiting for the holidays were frightened, I was extremely scared, we were up most of the rest of the night wondering if some bad guy with a gun was hiding in our back yard or some other nearby area. The homeowners contiguous to the bar have a video camera up and have many, many photos and videos of illegal activity in the alley outside the bar. They have shared that information with the police.

MIKO'S SPORTS LOUNGE - 710 WEST WILLOW STREET

The Long Beach Police Department reviewed calls for police service at 710 West Willow Street, from December 1, 2013 through December 31, 2015. These dates correspond to the time that Miko's Sports Lounge took ownership of 710 West Willow Street. A total of 221 calls for service were received during this time period. These calls were for loud music, groups, miscellaneous disturbances, fights, disputes, unwelcome subjects, burglary alarms, report calls and public intoxication.

Detectives reviewed police crime reports for the location and found five reports filed between September 2015 and December 2015. Four of the crime reports document unreasonable noise violations, and are supported by video evidence. The fifth crime report was related to an attempted murder that took place on December 27, 2015. Employees of Miko's Sports Lounge told detectives the suspect in the shooting was a regular customer of the bar.

During the month of January, 2016 a report was filed by Long Beach Police Department Detectives to document observed Long Beach Municipal Code violations inside Miko's Sports Lounge. The report detailed a disc jockey and karaoke singing. On the day of the observations, Miko's Sports Lounge was not permitted to offer karaoke or to have a disc jockey operating inside the establishment.

Based upon the listed facts, the Long Beach Police Department has determined the safety and welfare of the general area has been impaired by the persistent nuisance activity surrounding Miko's Sports Lounge. The Long Beach Police Department recommends denial of the OEP application at 710 West Willow Street for February 5-7, 2016, and any future requests for a period of 45 days commencing January 28, 2016 through March 12, 2016.

Based on a comprehensive evaluation, the Police Department recommends **DENIAL** of the applications for Occasional Event Permits (OEP) to take place April 28-30, 2016, and May 19-21, 2016, by Enaid's Way, Incorporated, dba Miko's Sports Lounge located at 710 West Willow Street.

### **Background**

Miko's Sports Lounge is a bar/tavern located on the south side of Willow Street between Maine Avenue and Oregon Avenue. The business is a for-profit corporation, Enaid's Way, Incorporated, and has been open for business since December 2013. The corporation currently holds a Type 48 (On-Sale General Public Premises) Alcoholic Beverage Control license. On September 23, 2014, Enaid's Way, Incorporated, applied for an Entertainment with Dancing Permit. The application was denied at the City Council hearing on March 17, 2015.

On January 29, 2016, Enaid's Way, Incorporated, dba Miko's Sports Lounge was denied an OEP for an event February 5-7, 2016. Enaid's Way, Incorporated, dba Miko's Sports Lounge was also prohibited from applying for any OEP's for a period of 45 days, commencing January 28, 2016, through March 12, 2016.

#### Crime Analysis

Detectives with the Long Beach Police Department reviewed the calls for service, crime reports, and arrests since Miko's Sports Lounge was last issued an OEP for an event on January 23, 2016. Detectives found a total of 12 calls for service from January 24, 2016, through April 14, 2016. The calls for service consisted of violation of an Entertainment Permit, loud music, loud groups, public intoxication, a fight, and a stabbing.

Detectives also reviewed the incident reports filed for 710 West Willow Street and found a total of three. One crime report was for an attempted suicide. A bar patron was inside with his girlfriend when they had an argument. The subject left the bar, attempted suicide, and was located approximately three blocks away from the bar. The second crime report was for the stabbing mentioned above. A subject was drinking inside the bar. The subject left the establishment and, a short time later, was seen having an argument in front of the bar with another subject when he was stabbed.

The third crime report relates to the only arrest made from the establishment during the evaluation period. On February 20 2016, the owner of Miko's Sports Lounge, Damitresse Yancey, was issued a citation for providing entertainment without a valid Entertainment Permit. Officers entered the establishment and conducted a compliance check. While inside, they heard and witnessed a disc jockey mixing music over loud speakers in violation of Long Beach Municipal Code section 5.72.110 (A). This was during the time frame that Miko's Sports Lounge was restricted from applying for Occasional Event Permits.

#### **Patrol Division**

West Division Patrol Commander Robert Smith was contacted for an opinion regarding the issuance of this permit. Commander Smith indicated there is a West Division Patrol Resource Officer actively working this address as a COPS location due to the high volume of calls for service and degree of complaints. There have been complaints for loud music from patrons' vehicles while parked in the neighborhood, loud music from the establishment, and drinking and urinating in public. Commander Smith said the approval of this Occasional Event Permits would increase the number of patrons and the need for additional police resources to respond to the increased calls for service at the location. The rights of the business should be weighed against the quality of life and security of the surrounding neighborhood. Commander Smith is opposed to the issuance of this Occasional Event Permits for Enaid's Way, Incorporated, dba Miko's Sports Lounge at 710 West Willow Street.

### Vice Investigations

Detectives with the Vice Investigations Section have filed two separate cases with the City Prosecutor's Office as it related to 710 West Willow Street. Detectives conducted an undercover investigation inside Miko's Sports Lounge on January 7, 2016. While inside the establishment, detectives witnessed a disc jockey mixing music through overhead speakers. The owner did not have a valid Entertainment Permit or Occasional Event Permit to have a disc jockey at the time. Detectives later presented the case with Deputy City Prosecutor Calvin George, who filed one misdemeanor count of providing entertainment without a valid Entertainment Permit in violation of Long Beach Municipal Code section 5.72.110 (A) against the owner Damitresse Yancey. (Case number 6LB00815)

As stated earlier, on February 20, 2016, during the evaluation period, the owner of the establishment, Damitresse Yancey, was issued a misdemeanor citation for providing entertainment without a valid Entertainment Permit, in violation of Long Beach Municipal Code section 5.72.110 (A) LBMC. Detectives presented the case to Deputy City Prosecutor Calvin George, who filed one misdemeanor count of providing entertainment without a valid Entertainment Permit in violation of Long Beach Municipal Code section 5.72.110 (A). ### Recommendations

Based upon Vice Section's investigations, West Division Patrol Commander's recommendation, and the crime analysis, the Long Beach Police Department has determined the safety and welfare of the general area has been impaired by the persistent nuisance activity surrounding the establishment. The peace and quiet of the neighborhood has also been disturbed on a continual basis. The owner has continued to show her non-compliance by providing entertainment without a valid permit. The Police Department recommends denial of the OEP applications for April 28-30, 2016, and May 19-21, 2016.

The owner of the property, Mr. Ron Mackey, was sent a letter dated March 18, 2016 by the Planning Department regarding the violations relating to the CUP for that location. That letter gave Mr. Mackey sixty-(60) days to bring his property into compliance with the CUP, or by May 18, 2016. Neither the Planning Department, as of two weeks ago, nor our office have been contacted by Mr. Mackey. As a result, we will have to wait and see what happens on May 18, 2016.

As for Miko's Sports Lounge and Ms. Yancey, she again attempted to apply for two Occasional Entertainment Permits (OEP) for the weekends of April 28-30, 2016 and May 19-21, 2016. Both OEP applications were denied by the Special Events Department based upon recommendations by the LBPD as well as the Planning Department. The Primary basis for the denial were the number of calls for service for the location since the end of January 2016. During that time span, there have been a number of disturbance calls involving Miko's and its patrons including a stabbing just outside the front entrance to the bar, an attempted suicide, as well as a number of disturbance calls involving patrons of Miko's. In addition, Ms. Yancey was again cited for having entertainment, a DJ, at the bar without an appropriate permit. Ms. Yancey received a similar citation back in January of this year. The misdemeanor citation which she received is being prosecuted by the City Prosecutor's office, with her arraignment on that charge currently set for May 20, 2016.

You are now up to date on what is happening with Miko's Sports Lounge and the location at 710 W. Willow Street. We are continuing to monitor the calls for service for Miko's. In response to your concerns about the location

moving forward, I can firmly assure you and the rest of the residents on Maine Avenue that the conditions at both Miko's Sports Lounge and 710 W. Willow Street are not going to revert back to the way they were in the past. At this point, both Mr. Mackey and Ms. Yancey, will have to comply with all the conditions contained in the CUP. If not, revocation proceedings for the CUP will be initiated by the City's Planning Department. In addition, all future OEP applications submitted by Miko's and/or Ms. Yancey will be thoroughly scrutinized by Special Events, the Planning Department, the LBPD and our office. The calls for service will be closely watched, and if the situation were to revert back to the level it has been over the last two years, the City could take action against Miko's Sports Lounge's business license, which could include a revocation proceeding.

The City's focus is to ensure that the conditions at the location continue change for the better. There will be no "going back to the usual."

Mr. Sanchez, has been over 45 days since our last correspondence regarding the compliance of Miko's Bar and the existing CUP referenced in your last communication dated May 27th-

Finally, with regard to the CUP for 710 W. Willow Street. Ms. Yancey provided a response to the Planning Department's letter detailing the existing CUP violations, on behalf of both Mr. Mackey and the Miko's Sports Lounge. It is my understanding that, in light of the ongoing violations of the terms of the CUP and the ongoing nuisance related activity, the proposed changes in Ms. Yancey's response were found to be inadequate. As a result, the Planning Department will be sending out a second letter to both Ms. Yancey and Mr. Mackey by early next week informing them of this determination. Pursuant to the relevant provisions of the Long Beach Municipal Code, they will have another forty-five (45) days in order to correct the violations and come into compliance the CUP. 



The property at the above referenced location was granted a Conditional Use Permit and a Standards Variance (Case No. 9505-01) on June 15, 1995. When this permit was granted, the property owner(s) agreed to a list of Conditions of Approval and signed a Conditions of Approval Acknowledgment form agreeing to the said conditions. The Department of Development Services, the Office of the City Attorney, as well as the Police Department have received numerous complaints and have determined that the property is in violation of the Conditions of Approval.

The Department did previously request on March 18, 2016, and received on May 13, 2016, responsive documents regarding the condition of compliance on this property. These documents are inadequate to demonstrate compliance with the conditions of approval. In addition, the establishment continues to operate as a public nuisance in detriment to the health, safety and general welfare of the surrounding community. Based on both the ongoing condition violations, as well as the public nuisance activity and resulting harm, the City has begun revocation proceedings for this property pursuant to Municipal Code Section 21.21.601. A revocation of the Conditional Use Permit for the premises will result in the loss of your right to sell alcoholic beverages at the property. The City is in the process of scheduling a revocation hearing before the Planning Commission and will be providing you with notice of the hearing date shortly.

The following Conditions of Approval remain out of compliance:

Condition #14 -The operator of the use shall provide security measures to the satisfaction of the Chief of Police.

The Long Beach Police Department received copies of the guard cards and security plan on May 9, 2016. This level of security is inadequate as evidenced by the Police Department comments, as well as the high number of calls for service, complaints and incidents in the surrounding neighborhoods. The current security plan calls for a single guard who monitors the front door, back parking, Maine Avenue, and works as a bar back clearing tables and maintaining ice and service items at the bar. On busier nights (not

defined in the response from Dede Yancy to Long Beach Police Department dated May 9, 2016) two security guards rotate between the front and rear doors.

The Long Beach Police Department requires, and the Planning Bureau concurs, that security guards should be employed only for security services and not involved in bar back duties, assistance to patrons or other non-security functions. A minimum of two security personnel during slower periods and three security personnel after 10 PM, as well as during all busier periods are necessary to control the front door, rear door and the exterior areas including parking, Maine Avenue and points between. The volume of complaints regarding patrons and noise in the parking area, as well as along Maine Avenue, indicate that the current security provided is both inadequate and ineffective. The number of altercations and other incidents of disruptive behavior related to Miko's patrons occurring in the surrounding community is particularly alarming and evidence of inadequate security and of the ongoing violation of Condition #14.

Condition # 20 – The applicant/developer shall be required to provide for and maintain five additional parking spaces from adjoining property owners by shared use agreement for the use of said parking after 5:00 P.M. seven days a week to the satisfaction of the Director of Development Services. Such agreement shall be recorded with the Los Angeles County Recorder's Office.

The parking agreement provided on May 13, 2016 is dated May 5, 2016, with "Five and Two Teriyaki" providing the parking. This agreement according to its own terms is specified to end that same day that it was issued. This document has not been recorded with the Los Angeles County Recorder as required by the condition. This arrangement is for the period of time from 9:00 P.M. to 2:00 A.M., whereas the condition requires parking beginning at 5:00 P.M. Additionally, customers of Miko's need to be informed of this parking opportunity through signage and the parking area must be secured in terms of noise and safety. This constitutes an ongoing violation of Condition #20.

Work without permits — On May 20, 2016, the subject property was served with a second notice of violation for work performed without permits. A previous stop work notice was issued on September 9, 2015. Please immediately cease all work at the premises and obtain the necessary permits prior to initiating work.

Public Nuisance — The continued operation of Miko's Sports Lounge has created a public nuisance with incidents of noise, crime and other disturbances which impact the health, safety and general welfare of the surrounding community at large. Evidenced by numerous noise complaints, police calls for service and the testimony of impacted residents, it is clear that the operation of Miko's Sports Lounge is not in due consideration to the health, safety and general welfare of the public. The Office of the City Attorney first opened a nuisance investigation for this property on March 18, 2014. Numerous meetings with residents and the business operator occurred in 2014 and both the property owner and proprietor made assurances that the business would operate in due consideration of the health, safety and general welfare of the community going forward. Unfortunately, the impacts to residents and incidents requiring a response from the Long Beach Police Department continued, and a new nuisance investigation was re-opened in December 2015.

Frequent noise issues behind the establishment, as well as on Maine Avenue, Oregon Avenue and 25th Way were caused by Miko's customers traversing between the establishment and their parked cars. At times they are simply loud, while at other times they are engaged in arguing and belligerent conduct. Such conduct impacts both the sleep patterns and public health of the residents in the surrounding community. Such disturbances have also included Miko's customers drinking and playing loud music in their vehicles, all to the detriment of the homes and residents in the area. In total, 248 calls for service since January 21, 2014 have occurred as a result of Miko's establishment.

Staff is particularly concerned with violent incidents occurring involving Miko's customers. These documented incidents include fights, disputes, an attempted suicide and an assault with a deadly weapon (stabbing), as well as a second assault with a deadly weapon (shooting). Such incidents are beyond any reasonable annoyance and impact the overall safety of the surrounding community. These instances of an ongoing public nuisance have not been abated. In fact, despite previous warnings to both the business operator and property owner, a large number of complaints were received regarding activities on May 20, 2016. A special event was advertised for that evening despite the fact that the facility had not secured an Occasional Entertainment Permit (OEP) and does not hold an ongoing Entertainment Permit.

In addition to a violation of the Conditional Use Permit conditions and numerous calls for police service, the establishment's proprietor has been cited on at least two occasions for hosting special events without the required OEP, on January 7, 2016 and February 20, 2016, respectively. In summary, the establishment has been, and continues to be, detrimental to the public's health, safety and general welfare, negatively impacting a substantial number of people at the same time.

The continued violation of the conditions of this Conditional Use Permit (Case No. 9505-01), including the above said conditions, form the basis for the prosecution, and/or revocation and termination of all rights thereunder by the City of Long Beach. Please be advised that you will be notified of the date of the revocation hearing before the City's Planning Commission under separate cover and/or any other enforcement proceedings available to the City under law.



REVOCATION OF BUSINESS LICENSE #BU21338610 DAMITRESSE YANCEY, DBA MIKO'S SPORTS LOUNGE - 710 W. WILLOW STREET

The Director of Financial Management is the issuing authority for business licenses issued pursuant to Long Beach Municipal Code Chapter 3.80. The Director is also empowered to suspend, deny, or revoke business licenses, pursuant to §3.80.429.1(A) LBMC, when a licensee has failed to comply with any applicable provision or requirement of law. Pursuant to this authority, the Police Department respectfully requests that you **REVOKE** the business license (BU21338610), issued to Damitresse Yancey, DBA Miko's Sports Lounge to operate a business at 710 W. Willow Street, for the following reason.

In December 2013, Damitresse Yancey was issued a business license to operate a bar at 710 W. Willow Street.

Since that time, the Police Department has had to respond to hundreds of calls for service regarding the business. In an attempt to mitigate the business' significant and negative impact our ability to provide law enforcement services to others, Long Beach Police Officers proactively conducted investigations at the business—some of which resulted in misdemeanor citations being issued. The respective Patrol Commander was forced to attend community meetings, along with his staff, to address concerns the bar's neighbor had. Additionally, the Patrol Commander and his staff were required to address the bar's continuing nuisance activity with other City Departments, impacting their workload in addition to his own. The following is a summary of the nuisance activity associated with the business. Though the city has met and spoken with the business owner, Damitresse Yancey, on several occasions, she is unwilling or unable to abate the nuisance her business has created:

- Approximately 250 Police Calls for Service between January 1, 2014 through May 25, 2016
- December 27, 2015 Attempted murder / shooting
- January 7, 2016 Citation for providing entertainment without the required Entertainment Permit
- February 20, 2016 Citation for providing entertainment without the required Entertainment Permit
- March 27, 2016 Subject attempted suicide outside, after drinking inside bar
- March 30, 2016 Stabbing that occurred outside, involving a person that was just drinking inside, and who went back inside after being stabbed outside
- The business is, and has been, out of compliance with their Conditional Use Permit (Please contact Department of Development Services for further information)
