RECOMMENDATION:

Authorize the Director to execute the First Amendment to Fitness Provider Permit No. 33366 with Andy Felter, dba S&J Fitness and Kickboxing at Wardlow Park; and amend Attachment "A" of the Permit as needed. (District 5)

DISCUSSION

Pursuant to Section 16.16.060 of the Long Beach Municipal Code, Parks and Recreation Commission approval is required for all Fitness Provider Permits for individuals and businesses wishing to use open park space for group exercise classes, personal training and/or boot camps within City Parks (Commercial Recreation/Instruction). As of December 1, 2016, The Department of Parks, Recreation and Marine (PRM) has received one Permit extension request from an existing Permittee at Wardlow Park. A summary of the aforementioned Amendment to be approved is attached for your consideration and approval (Attachment A).

FISCAL IMPACT:

The Suggested Action will result in revenue in the amount of \$350 in FY 17; and \$58 in FY 18, which shall accrue to the General Fund (GP) in the Department of Parks, Recreation and Marine (PR).


