The City Council hereby finds that none of said records: 21 A. Affect the title to real property or liens thereon; B. Constitute official court records; 22 23 C. Constitute records which are required to be kept by statute; 24 D. Constitute the original or record copies of the minutes, ordinances or resolutions of the City of Long Beach or any City Board or Commission. 25
