23	Block Grant. The City Manager or his designee is hereby authorized and empowered to		
24	execute in the name of the City of Long Beach all necessary applications, contracts		
25	agreements, amendments and documents of any kind hereto for the purposes o		
26	securing block grant funds and to implement and carry out the purposes specified in the		
27	grant application.
