Subject The Gaslamp and our neighborhood

For the past few months, at the request of one of our neighbors, I have been attending "Permit" meetings of the Gaslamp Restaurant on the corner of PCH and Loynes Drive. The Gaslamp is the upscale restaurant that replaced "Live Bait", "Some unremembered night club", Bentleys and even an Olive Garden for those of us that have been around since the 70's (and no not the Olive Garden franchise we know today). It has been the source of many headaches, both figuratively and literally.

For many years, the site was the source of unwanted noise, drunk patrons and other assorted less than desirable activities. Then Alicia & Jennifer took over the Gaslamp, serving the community with fine foods and an opportunity to have some wine or alcohol with our meal. Then they started allowing private parties like weddings and church services at the site. Not exactly sleazy stuff, but they needed an entertainment permit for weddings etc. which they got, unopposed. Now they are trying to get a dance permit, after all what would a wedding be without a chance to dance and patrons also wanted to dance to DJ's and bands that would appear at the place in the evenings.

They are going to the City Council on Sept. 11th, for consideration of an approval of a dance permit, but there are a some who are concerned about the issuance of such a permit. They have registered one primary complaint.

LOUD NOISES FROM THE MUSIC and PATRONS and THEIR AUTOS - PARTICULARLY WHEN THEY LEAVE THE PREMISES.

Since then they have soundproofed the premises so well that even a surprise visit from the LB Health Dept. found there was no noise emanating from the building (they thought the band had stopped playing which it had not) and that it was hard to distinguish between parking lot noise and street noise--you know how noisy PCH can get.

They have also increased security in their parking lot, encouraging patrons who are leaving the premises to respect the rights of neighboring residents and be quiet. These guards are posted all around the premises and are wearing yellow jackets so that they are easily identified. In addition, there are signs posted all over the place re: respecting the neighbors.

They have also implemented "Valet" service at the suggestion of UPENA President Janice Dahl so that cars parked adjacent to areas where people are living are parked along the fence by persons who will not make lots of noise. In addition, they are investigating sound absorbing landscaping along those back fences to assure there is less intrusion into the lives of their neighbors, the Mobile Homes, Whalers Cove and adjacent housing developments.

Loynes Drive will have red curbs and "no parking" and they have closed the entry adjacent to the Marina Bahia Yacht Club parking lot, which at times creates its own "Night Music", not to mention the traffic that comes through from the Golden Sails.

I believe that we should support our neighbors. I very much believe that the woes of each of our neighbors will eventually be our woes too. I would suggest that when, and if, the Gaslamp ceases to be a "Good Neighbor" we should step up and protest their presence, but given their honest and sincere efforts to comply with the concerns of all of us, we should support their efforts.

Therefore, I am asking if you have a moment, could you please sent a note to the City Council, which will be considering their permit on the 11th of September, asking them to approve their permit. If you know any of the City Council personally, a phone call would also be great. I am personally going to go to support them since I know they sincerely want to work with the community. I also would suggest you take the family and go have dinner at their place--the food is great and it is a very wholesome environment. If you are into dancing, hopefully you will have a place to go soon as well.


