WHEREAS, pursuant to a Notice Inviting Bids for Annual Contract for Concrete Repairs and Related Improvements in the City of Long Beach, California, dated November 30, 2011, and published by City, bids were received, publicly opened and declared on the date specified in said Notice; and

WHEREAS, City and Contractor entered into Contract No. 32487 (the "Contract") for the work described in the bid documents; and

WHEREAS, City and Contractor entered into a First Amendment to the Contract to extend the term to December 31, 2013 and increase the not to exceed amount to \$8,000,000; and

WHEREAS, City and Contractor entered into a Second Amendment to the Contract to extend the term to December 30, 2014 and increase the not to exceed amount to \$13,000,000; and

WHEREAS, City and Contractor entered into a Third Amendment to the Contract to extend the term to December 30, 2015 and increase the not to exceed amount to \$18,000,000; and

WHEREAS, City and Contractor entered into a Fourth Amendment to the Contract to extend the term to December 30, 2016 and increase the not to exceed amount to \$23,000,000; and

WHEREAS, City and Contractor again desire to extend the term;
