## SECOND AMENDMENT TO AGREEMENT NO. 34132

THIS SECOND AMENDMENT TO AGREEMENT NO. 34132 is made and entered, in duplicate, as of November 23, 2016, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 20, 2015, by and between JOVENVILLE, LLC DBA WE THE CREATIVE, a California limited liability company ("Consultant"), with a place of business at 2810 Villa Way, Newport Beach, California 92663, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed graphic design and creative services; and

WHEREAS, City and Consultant entered into Agreement No. 34132 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, City and Consultant entered into a First Amendment to the Agreement to increase the amount by \$28,500 for a total not to exceed amount of \$38,500; and

WHEREAS, the City and Consultant desire to increase the Agreement amount by \$57,400 for a total not to exceed amount of \$95,900;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 1.A. of Agreement No. 34132 is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Ninety-Five Thousand Nine Hundred Dollars (\$95,900), at the rates or charges shown in Exhibit "B"."
