**RESOLUTION NO.** RES-17-0024 A RESOLUTION OF INTENTION TO VACATE THE NORTH/SOUTH ALLEY LOCATED NORTH OF SPRING STREET BETWEEN ELM AVENUE TO THE EAST AND LONG BEACH BOULEVARD TO THE WEST, IN THE CITY OF LONG BEACH, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, PURSUANT TO THE PUBLIC STREET, HIGHWAYS AND SERVICE EASEMENTS LAW (DIVISION 9, PART 3, CALIFORNIA STREETS AND HIGHWAYS CODE); FIXING A TIME AND PLACE FOR HEARING ALL PERSONS INTERESTED IN OR OBJECTING TO THE PROPOSED VACATION

The City Council of the City of Long Beach resolves as follows:

16 Section 1. The City Council of the City of Long Beach hereby elects to 17 proceed under Division 9, Part 3, Chapter 3, of the California Streets and Highways Code 18 (Section 8320 et seq.), as amended, generally known and referred as the "Public Street, 19 Highways and Service Easements Law", and hereby declares its intention to vacate the 20 north/south alley located north of Spring Street between Elm Avenue to the east and 21 Long Beach Boulevard to the west, in the City of Long Beach, County of Los Angeles, 22 State of California, described more particularly as follows:

24 A STRIP OF LAND, 10 FEET WIDE, THAT LIES EAST OF LOTS 1 25 THROUGH 12 AND WEST OF LOTS 13 THROUGH 24, IN BLOCK A, OF 26 TRACT NO. 3207, IN THE CITY OF LONG BEACH, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AS PER MAP RECORDED IN BOOK 28 33, PAGE 7 OF MAPS, IN THE OFFICE OF THE COUNTY RECORDER

VALVES, APPURTENANCES FOR THE TRANSPORTATION OF WATER AND GAS, WITH THE RIGHT OF INGRESS TO AND EGRESS FROM THE SAME, OVER, THROUGH, UNDER, ALONG AND ACROSS THAT CERTAIN PROPERTY VACATED HEREWITH; AND PURSUANT TO ANY EXISTING FRANCHISES OR RENEWALS THEREOF, OR OTHERWISE, TO CONSTRUCT, MAINTAIN, OPERATE, REPLACE, REMOVE, RENEW AND ENLARGE LINES OF CONDUITS, CABLES, WIRES, POLES AND OTHER CONVENIENT STRUCTURES, EQUIPMENT AND FIXTURES THE OPERATION OF TELEPHONE LINES AND OTHER FOR COMMUNICATION LINES, AND FOR THE TRANSPORTATION OR DISTRIBUTION OF ELECTRIC ENERGY, AND INCIDENTAL PURPOSES INCLUDING ACCESS AND THE RIGHT TO KEEP THE PROPERTY FREE FROM INFLAMMABLE MATERIALS, AND WOOD GROWTH, AND OTHERWISE PROTECT THE SAME FROM ALL HAZARDS IN. UPON AND OVER THE PART VACATED, ACCESS FOR MAINTENANCE OF THE ABOVE-MENTIONED FACILITIES MUST BE MAINTAINED AT ALL

TIMES. NO IMPROVEMENTS SHALL BE CONSTRUCTED WITHIN THE EASEMENT WHICH WOULD IMPEDE THE OPERATION, MAINTENANCE OR REPAIR OF SAID FACILITIES. CONSTRUCTION OF ANY IMPROVEMENTS, INCLUDING CHANGES OF GRADE, SHALL BE SUBJECT TO THE PRIOR WRITTEN APPROVAL OF ALL THE CITY DEPARTMENTS AND PUBLIC UTILITIES RESPONSIBLE FOR THE ABOVE SAID FACILITIES.

9 Section 2. All of the foregoing real property is shown on the map or plan
10 thereof, attached hereto as Exhibit "A", and on file in the office of the City Clerk, which
11 map or plan is known and referred to as "City of Long Beach Department of Public Works
12 Vacation Sketch No. 1019V".

Section 3. The City Council hereby fixes the 11th day of April, 2017 at
the hour of 5:00 p.m., as the time and the City Council Chamber, Plaza Level of the City
Hall, 333 West Ocean Boulevard, in the City of Long Beach, California, as the place for
hearing all persons interested in or objecting to the proposed vacation.

Section 4. The City Council hereby directs that notice of said hearing on
this proposed street vacation be published for at least two (2) successive weeks prior to
the hearing and in the manner provided by Section 8322 of the State Streets and
Highways Code.

Section 5. The City Council hereby directs that notice of this street
vacation be posted conspicuously along the street proposed to be vacated at least two
(2) weeks before the date set for hearing and in the manner provided by Section 8323 of
the State Streets and Highways Code.

Section 6. This resolution shall take effect immediately upon its adoption
by the City Council, and the City Clerk shall certify to the vote adopting this resolution.




