20	Deborah Ellis certify that Deborah Ellis has not and will not receive a Golden Handshake							
21	or any other retirement-related incentive; and							
22	WHEREAS, the City Auditor with City Council approval hereby appoints							
23	Deborah Ellis as an extra help retired annuitant to perform the duties of the Special							
24	Projects Officer for the City of Long Beach under Government Code section 21224,							
25	effective April 22, 2017; and

WHEREAS, the compensation paid to retirees cannot be less than the 4 minimum nor exceed the maximum monthly base salary paid to other employees 5 6 performing comparable duties, divided by 173.333 to equal the hourly rate; and

7 WHEREAS, the maximum base salary for this position is \$10,500 monthly and the hourly equivalent is \$60.577, and the minimum base salary for this position is 8 9 \$7,000 monthly and the hourly equivalent is \$40.385; and

17 The City Council hereby certifies the nature of the Section 1. 18 appointment of Deborah Ellis as described herein and detailed in the attached 19 appointment letter and that this appointment is necessary to fill the critically needed 20 position of Special Projects Officer for the City of Long Beach by April 22, 2017, for the 21 purpose of assisting with the facilitation of the Enterprise Resource Planning (ERP) 22 project for the City's new Financial/Human Resources system.
