It has been stated my business is a "community nuisance". I am a responsible business owner. I am more than willing to operate in accordance with regulations, statutes, and ordinances affecting a business such as mine. I would like the opportunity to demonstrate who I am as a responsible business owner more than willing to mend community issues and concerns if afforded the chance. The Wrigley District not only provides my business location, I am also a home owner in this community.

I am reaching out to you as I have been unsuccessful in my efforts to speak to or meet with my council member for any corrective dialog in regard to my business.

I would like to request the following:

- 60 days to work in conjunction with all necessary City Departments to bring my business into compliance.
- Freeze City fines so that I may "catch up" to any outstanding payments due.
